For the last 17 months I have been harassed, stalked, bullied and borderline been pushed to suicide. I have made an attempt once. I have 287 files on a usb I am taking to the police station, they include screenshots, videos, pdfs, emails and so much more. I have been through hell for 16 months so unless someone can confirm they have used my services, remove their goddamn reviews because it is just these fucking liars using my kids to make me

seem deranged to illustrate their narrative. Look at all the other reviews. the two negative are just slanderous bullshit and it's so goddamn obvious.

If there was any truth to their slanderous bullshit about unencrypted information, the only way someone would be able to tell is if they were doing something illegal. They have tried this lie for over 6 months. I continuously prove it but they stand by it because of how it sounds.
