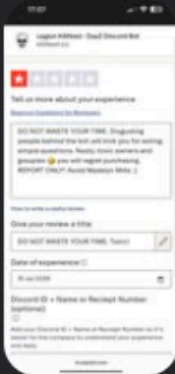

Hi Ansa,

Your decision to reinstate a review from an account named "Cunt" — containing false, defamatory claims like "robs people" and "blocks them" — is both negligent and absurd.

Let me be absolutely clear:

- The reviewer has never used our service — no Discord join, no PayPal transaction, no ticket, no login — nothing.
- The display name “Cunt” is a textbook violation of your own Obscenity and Account Name guidelines.
- The statement “robs people for there money” is not criticism — it is a provably false factual allegation with clear malicious intent.
- This review was part of a coordinated harassment campaign already reported to Thames Valley Police (Case Ref: 43250388789).

I am no longer treating this as a support ticket. You are now on formal legal notice.

Your platform has failed to act “expeditiously” after notification — under Section 5 of the UK Defamation Act 2013, that strips you of immunity. The Voller precedent (HCA 27, Australia) and recent U.S. CDA §230 erosion (Henderson v Source) affirm the same in both my and the reviewer’s jurisdictions.

A full legal demand has been drafted and will be sent to your Legal Department. If this review is not permanently removed and the account suspended within 24 hours, Trustpilot will be added as a co-defendant in all forthcoming actions.

I suggest you escalate this immediately to someone who understands the legal consequences of inaction.
