Dear Thames Valley Police,

Thank you for your email regarding victim feedback. However, I believe there may have been a misunderstanding. My correspondence dated **4 August 2025** (attached) is a **formal criminal complaint** detailing a coordinated online harassment, defamation, and fraud campaign by a UK resident (Mr. Danny Hayes) against me and my business, Legion Kiltfeed. The complaint includes:

- **27 distinct violations of UK law** (e.g., harassment, malicious communications, incitement to fraud).
- **Jurisdictional justification** confirming Thames Valley Police's authority to investigate.
- **Evidence bundle** (screenshots, chat logs, URLs) substantiating all claims.

This is not general feedback but a **request for urgent police action**. I kindly ask you to:

1. **Review the attached complaint** (PDF) and its evidence.
2. **Reopen Case Ref: 43250388789** or assign a new reference.
3. **Confirm next steps** for investigation, including how to submit additional evidence.

The perpetrators' actions are ongoing, causing severe reputational, financial, and psychological harm. I urge immediate attention to this matter.

But so far, my count is:

- **Defamation Act 2013** – 7 separate libel statements (“robs people”, “trash bot”, etc.).
- **Malicious Communications Act 1988 §1** – 7 counts for sending grossly offensive falsehoods intended to cause harm.
- **Communications Act 2003 §127** – 7 counts for “grossly offensive” online messages.
- **Protection from Harassment Act 1997** – 1 ongoing course of conduct (the whole campaign).
- **Fraud Act 2006 §2** – 2 counts for urging baseless PayPal charge-backs.
- **Serious Crime Act 2007 §44-46** – 3 counts for encouraging others to commit those frauds / shut the business down.

That’s **27 actionable hits** across six UK statutes—and every fresh post just adds another bullet to the list.

Thank you for your response. I understand the jurisdictional complexities raised; however, I wish to clarify that the alleged offenses (harassment, defamation, and malicious targeting of my business) originate from a UK-based individual, and the harmful conduct is occurring within your jurisdiction.

Under UK law, particularly the **Malicious Communications Act 1988** and the **Protection from Harassment Act 1997**, these actions may constitute criminal offenses. The fact that I am Australian does not negate the perpetrator’s accountability under British law.

I respectfully request the following:

1. **Formal Investigation:** The individual’s actions (documented in attached evidence) include deliberate attempts to damage my business through false claims and coordinated harassment. This falls squarely within UK jurisdiction.
2. **Interpol Referral:** If Thames Valley Police requires initial action by Australian authorities, please provide a formal referral request outlining the specific UK legal provisions violated. My local police can then escalate this via Interpol with clear guidance.

3. **Cross-Border Cooperation:** The UK-Australia Mutual Legal Assistance Treaty (MLAT) facilitates such cooperation. I urge you to liaise with the Australian Federal Police (AFP) directly if needed.

Key Evidence Highlights:

- Screenshots of the UK-based individual inciting others to "shut down" my business (a criminal threat under UK law).
- Defamatory posts falsely accusing my business of unprofessional conduct (potential violation of the **Defamation Act 2013**).
- Harassment campaigns targeting paying customers (breaching the **Computer Misuse Act 1990** if involving false reports to platforms like Discord).

I am happy to provide further details or sworn statements. Given the severity of this conduct—and its impact on my livelihood—I trust you will reconsider your position or advise how to proceed under UK legal frameworks without delay.

I've been putting up with attacks like this for the last two year, the cops here didn't even do anything about one of this fuckwit's friends using photos of my kids to antagonise me. It took the eSafety Commission 3 months to have images of minors taken down. We're still a part of the Commonwealth, doesn't that get us some kind of protection or mateship? Otherwise, why does Australia pay so much tax to the king?

I'm just trying to keep my business alive, I'll be homeless in two weeks of it shutting down so there won't be much of a reason to stay alive.
