Dear Trustpilot Content Integrity Team,

Your 2 August 2025 email advises that the review left by user “WARZONE” has been reinstated because your automated assessment did not flag it as defamatory. I respectfully request an immediate manual review on the following grounds:

1.

Reviewer never used the service

*

We hold no Discord join, subscription, payment, or ticket history for this individual.

*

PayPal confirms zero transactions from any account linked to this user.

2.

False factual allegations

*

Claim that I “rob people for their money” is demonstrably untrue; zero chargebacks or disputes have ever succeeded against Legion Killfeed.

*

Statement that the bot is “toxic” and “do not waste your time” is not opinion about personal experience—it is presented as fact from a non-customer, with intent to deter trade.

3.

Co-ordinated smear campaign

*

The same user openly recruited others on Facebook to post identical negative reviews (screenshots available).

*

A police report is filed with Thames Valley Police (Ref 43250388789) documenting this harassment.

4.

Material harm

*

Within 48 hours of the review, we recorded a 7 % drop in new-user sign-ups traced directly to the Trustpilot page.

*

The review has already been cited in Discord servers as “proof” my service is fraudulent.

UK law (Defamation Act 2013, s.1) defines a statement as defamatory if it is false and likely to cause serious financial loss. The above criteria are plainly met. Automated screening alone is insufficient where clear evidence has been provided.

Requested action

*

Remove the review permanently under your Defamation and Harmful Content policy.

*

Escalate to a senior human reviewer, as required when automated assessment is challenged with documentary proof.

All supporting evidence (transaction logs, Discord audit logs, Facebook screenshots, police reference) is ready for immediate upload.
