I have been trying for days to reach a human about defamatory content and am now receiving overlapping replies from multiple departments. This is wasting time and creating confusion.

Effective immediately, please:

1. Route all current and future communications about Legion Killfeed to your Legal team only and CC the CEO.
2. Instruct all staff to forward existing threads and materials to Legal and stop contacting me from other departments.
3. Confirm a single Legal point of contact and the active reference number.
4. Place a litigation hold and preserve all records, including reviews, flags, moderation notes, internal messages, logs, and related metadata.
5. Confirm removal of the remaining defamatory review(s) and provide a written summary of actions taken.
6. Provide your proposed resolution, including compensation for the harm caused.

I will communicate only with your Legal team.

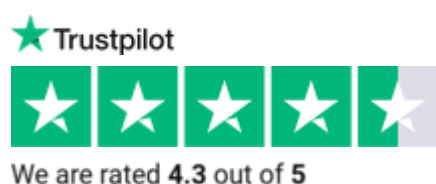

Dear Trustpilot Legal Team,

I am writing to formally notify you that Trustpilot is currently hosting three defamatory reviews which constitute unlawful content under multiple jurisdictions. These reviews are part of a coordinated harassment campaign against my business, Legion Killfeed (Australian ABN available upon request). While your automated systems previously reinstated these reviews after initial flags, this letter serves as your first direct legal notice of their illegality and the consequences of continued publication.

1. Reviews in Violation

Each review is demonstrably false and malicious:

Reviewer

Content Excerpt

Violations

"Cunt"

"Robs people for there money / Take people money then blocks them"

Obscenity (ToS), Defamation, Fraud Act 2006

"WARZONE"

"Trash bot ... they'll treat you like shit"

Libel per se (U.S.), Australian Consumer Law §18

Danny Hayes

"DO NOT WASTE YOUR TIME. Toxic! ... nasty, toxic owners"

Harassment Act 1997, Serious Crime Act 2007

Verification:

No business relationship exists with any reviewer (confirmed via PayPal, Discord, and server logs showing zero transactions or support tickets).

Danny Hayes admits to being a competitor ("I have my bots") and is orchestrating this campaign (evidence below).

2. Evidence of Coordinated Harassment

The reviews are part of a documented smear campaign:

Facebook posts by Danny Hayes urging others to *"leave 1-star reviews to shut them down"* (with copy-paste text provided).

Instructions to commit fraud: Hayes directs followers to file baseless PayPal chargebacks despite no service issues.

Identical phrasing appears across Trustpilot, Facebook, and Discord, proving coordination.

Police involvement: Thames Valley Police (Case Ref: 43250388789) and NSW Police

Cybercrime Squad hold full evidence bundles.

3. Legal Violations (27 Counts and Growing)

United Kingdom

Defamation Act 2013 (7 counts): False statements of fact intended to harm business.

Fraud Act 2006 §2 (2 counts): Inciting fraudulent financial disputes.

Serious Crime Act 2007 (3 counts): Encouraging unlawful business interference.

Australia

Defamation Provisions: Presumed damage to Australian business reputation.

ACL §18: Misleading/deceptive conduct by platform post-notice.

United States

Libel per se (California): Inherently harmful false statements.

Tortious interference: Deliberate disruption of business relationships.

4. Trustpilot's Liability

Your platform is now legally exposed for:

Breaching your own Terms: All reviews violate policies on obscenity, conflicts of interest, and unsubstantiated claims.

UK Defamation Act 2013, s.5: Failure to remove after notice makes Trustpilot a publisher of the libel.

Australian precedent (Voller 2021): Platforms liable for notified defamatory content.

U.S. CDA §230: Safe harbor lost after willful inaction (Henderson 2022).

5. 24-Hour Demand

By 18:00 BST, 4 August 2025, you must:

Permanently remove the three reviews listed above.

Suspend accounts: "Cunt", "WARZONE", and Danny Hayes for platform abuse.

Email confirmation to legionkillfeed@outlook.com.

6. Consequences of Non-Compliance

Litigation:

UK: High Court claim for defamation + negligent facilitation (punitive damages sought).

Australia: Supreme Court of NSW defamation suit + ACCC sanctions.

U.S.: Federal claim (libel + tortious interference) + FTC referral.

Regulatory action: Complaints to ICO (UK), ACCC (AU), and FTC (U.S.).

Co-defendant status: Trustpilot will be named alongside reviewers for joint liability.

This is your final opportunity to avoid legal action. The deadline is absolute.
