4. Place a litigation hold and preserve all records, including reviews, flags, moderation notes, internal messages, logs, and related metadata.
5. Confirm removal of the remaining defamatory review(s) and provide a written summary of actions taken.
6. Provide your proposed resolution, including compensation for the harm caused.
