Hi Ansa J,

I have told your team 10 times now. Stop sending duplicate, robotic replies about past actions. As at 7:02pm AEST, Thu 14 Aug 2025, there has been no change since my Calderbank Offer. Your “transparency” page still omits the positive reviews you have hidden while defamatory items remain or are re-published. Your emails ignore that reality and do not engage with the evidence or the legal notice. They are causing further aggravation.

- Do not contact me again from Content Integrity, Support or any other queue. All communications must be through Legal only.
