Dear Lauren,

On 16 August 2025, your staff wrote to me confirming in writing:

"Trustpilot does not currently operate under an Australian Business Number (ABN). Our services are provided by our Danish parent company, Trustpilot A/S."

Today (18 August 2025), you have now stated:

"Our legal entity in Australia is called Trpilot Pty Limited and our ABN is 37 605 147 260... Our registered office address is Level 22 400 George Street, Sydney 2000."

These two positions cannot both be true. Either:

1. Your original written admission (no ABN) was correct – in which case you are in breach of the *A New Tax System (Australian Business Number) Act 1999* s.8 for refusing lawful disclosure, or
2. Today's statement is accurate – in which case you and your colleagues have previously misrepresented your legal status in writing, which is itself misleading and deceptive conduct under *Australian Consumer Law* s.18.

This contradiction, coupled with your refusal to route matters to Legal as lawfully requested, only compounds your liability.

As you are aware, my **Calderbank offer** remains ignored, despite repeated notice. I will now proceed on the basis that:

- Your first admission (no ABN) is taken as your true position.
- Trustpilot has operated unlawfully in Australia without compliance.
- Trustpilot has continued to knowingly publish defamatory content after notice, aggravating damages.

The optics of this are dire: a London-listed company caught lying about its ABN, obstructing Legal contact, and facilitating coordinated attacks on an Aboriginal Australian's sole income stream.

Either your Legal team responds directly within 48 hours with a coherent position and settlement framework, or proceedings will commence and costs will be sought on an indemnity basis.

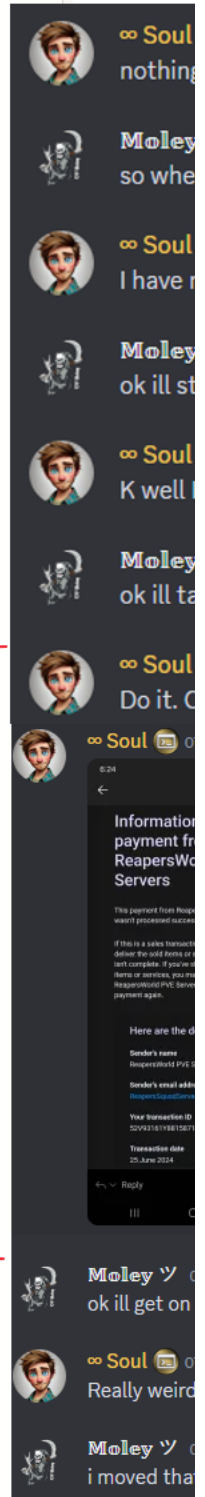
