

# Subject: Appeal - I reported the harasser; enforcement was applied to me instead. PLEASE READ ALL ATTACHMENTS!

## Ticket details

I am appealing the harassment/bullying enforcement placed on my account. The message in question was a notice to cease sent to a user who is part of a long-running, targeted campaign against me. This group uses alternate accounts, brigading, suicide-baiting, and defamatory claims (including calling me a pedophile and a "woman basher"). They evade blocks to restart contact, then report my defensive replies.

Yesterday, a member of that group contacted me from a new account after a prior block. I told him he is on notice and referenced pending litigation relating to conduct across multiple platforms. That notice was not harassment; it was a defensive response to persistent abuse and block evasion.

### Relevant facts

Repeated suicide-baiting and slurs directed at me  
Prior use of images of my underage children to harass me  
Documented block evasion to re-initiate contact before this report

I was the reporting party. I reported his message through the in-app flow. After my report, enforcement was applied to me based on my reply in that same thread. Please review the conversation context, confirm the block evasion and prior history, and apply enforcement to the correct account. Remove the strike from my account.

### Sequence

A previously blocked actor re-initiated contact using a new account.  
I reported that message in-app.  
Enforcement was then taken against me for my reply in the same thread.  
The re-contact was initiated by them, not me.  
My reply was a concise notice to cease and to record the conduct. It contained no threats and was not intended to harass.

### Requests

Reverse the strike on my account  
Apply enforcement to the user who re-contacted me in violation of prior blocks  
Note my account for ongoing targeted harassment to avoid reporter-retaliation issues

Important: Please do not send a canned “use the in-app reporting tools” response. I have reported every relevant event through the in-app flow, continuously, for six years. I am requesting a substantive review of the evidence, the conversation history (including deleted messages), block logs, and linkage across these accounts, and for this enforcement to be corrected. This harassment began on Discord, has spread across four platforms, and has caused real-world harm and reputational damage in a niche community. Apply enforcement to the perpetrators, not the reporting victim.

I have attached several pieces of evidence and the attachment that was attached to the message that you deemed as harassment (which if you had read it, you would have seen the chronology of their contact).

Two very important notes I have.

1) **#61451498** (<https://support.discord.com/hc/en-us/requests/61451498>) was Marked as Solved on that message without any review of the evidence. I re-filed **#61451749** (<https://support.discord.com/hc/en-us/requests/61451749>) in the correct category with an additional note:

"What needs attention is the substance.

Closing tickets for form hygiene before reading the record looks like moderation triage failure. I do not want to cause Discord issues, but if I am forced to seek external oversight again, I will contact the Australian eSafety Commissioner. I have previously had to escalate there to secure the removal of images of my underage children. Another referral during an open appeal—especially where I have supplied extensive documentation—will reflect poorly on Discord's internal review process and risks becoming part of a broader discussion about improving online-safety standards. This is particularly relevant while I am pursuing legal action against other platforms these actors have used to harass me.

Please conduct a human review of the evidence already provided, rather than redirecting me back to form selections."
