Legal Complaint

Explanation of why the content on the above URL is unlawful (Defamation, Australia):

What the page says

The Reddit post asserts that my business, “Legion Killfeed,” “collects and sells your files” and that, “before the killfeed he deleted servers,” presented as statements of fact about my commercial conduct. These are false and materially harmful factual claims about a business.

Why this is defamatory at law

Under the Defamation Act 2005 (NSW) (as amended), a publication is defamatory where it:

identifies the claimant and is published to third parties;

conveys one or more defamatory imputations; and

causes serious harm to the claimant’s reputation (s 10A serious harm threshold).

The post identifies my business by name and was published on a large public forum. It conveys imputations that I engage in theft of customer files, dishonesty, and sabotage of servers. These imputations are plainly damaging to reputation and trade. The allegations are false.

Specific defamatory imputations

The words complained of carry the following imputations:

That my business steals or misappropriates customers’ files.

That my business sells customers’ files for profit.

That I or my business delete or sabotage customers’ gaming servers.

Each imputation is false and injurious to my business reputation.

Falsity and lack of lawful defence

The allegations are false. My service for DayZ console servers does not access, copy, sell, or distribute customers’ files, nor does it have any capability to cancel or delete third-party servers. The statements are not protected “honest opinion” because they are presented as verifiable facts and are not based on true or properly stated material. They are not fair report, qualified privilege, or public-interest journalism. No recognised defence under the Act applies (for example, s 25 justification and s 29 honest opinion cannot succeed because the core assertions are untrue and stated as fact).

Serious harm and commercial impact (s 10A)

The post has diverted potential customers, caused existing subscribers to question safety, and has led to lost prospects and refund requests. The harm is more than trivial and satisfies the serious harm threshold. I am prepared to provide contemporaneous records of cancellations and sales inquiries referencing this post.

Context of competitive malice

The author is a direct commercial competitor operating a rival product. The post targets my brand name to discourage use of my service and to redirect customers. This supports an inference of malice and weighs against any defence.

Good-faith steps taken with the platform

I reported this content to Reddit and attempted resolution. Reddit has not acknowledged nor removed the post. I am therefore requesting removal from Google Search results for defamation.

Delist the URL identified above from Google Search on the basis that it contains defamatory content that is false, causes serious harm to my business reputation, and lacks any applicable defence under the Defamation Act 2005 (NSW), including s 10A (serious harm) with no available defences such as s 25 (justification) or s 29 (honest opinion). ...
