Facebook/Meta Legal,

I am Anthony Brodie, owner of Legion Killfeed. I am the person defamed and the rights owner referenced in your auto-reply. This is a formal legal notice and cease and desist. Route it to Legal for defamation removal and evidence preservation.

Unlawful publications you are hosting

1. Joel Walker post and later edit naming me and my business

Why this is unlawful

These statements are false, they clearly identify me and my business, and they impute serious criminal conduct and dishonesty. They meet the serious harm threshold under the Defamation Act 2005 (NSW) as amended 2020 section 12A. The 25 Oct 2025 Walker post was edited to add my name and business which is a republication. The later Walker post and the Santos and Putzier threads are substantially similar republications.

Meta was already on notice

Your Pro Team acknowledged my report on 3 Nov 2025 under reference 1332648995224789. Despite that notice, the publications remained online and continued to circulate. They have now been visible for about 14 days since 25 Oct 2025. Keeping them up after formal notice while I was actively seeking removal shows bad faith and aggravates the harm.

Policy does not supersede law

Your internal policies and form selections do not override applicable law. Any routing requirements or triage limitations are Meta's responsibility, not mine. I am not going to manage Meta's failure to administer its services correctly. This is a legal notice upon receipt whether or not it lands in the right department.

Cease and desist

Joel Walker, Daniel Santos, and Nathan Lane Putzier must cease and desist from publishing or republishing statements that accuse me of pedophilia or that state or imply that my business, Legion Killfeed, is associated with child sexual offences or is a scam. Treat any further edit, share, story, repost, or substantially similar text as republication after notice.

Demands

1. Remove the Joel Walker post at <https://www.facebook.com/groups/makedayzgreatagain/posts/1468775737537580/> and all edited versions, shares, stories, previews, and cached renders.
2. Remove the later Joel Walker republication at <https://www.facebook.com/groups/makedayzgreatagain/permalink/1480886512993169> and any duplicates.
3. Remove the Daniel Santos thread at <https://www.facebook.com/groups/299960322481369/posts/757760916701305/> and associated comments that solicit attacks.
4. Remove the Nathan Lane Putzier post at <https://www.facebook.com/share/p/1DU13Acu3Y/> and associated comment threads.
5. Place a litigation hold on all internal notes, moderator actions, edit histories, analytics, and related telemetry for the above URLs, the groups, and the publisher accounts.
6. Confirm removal in writing and provide a named Legal point of contact.
7. Implement measures within those groups and accounts to prevent republication of the same imputations.

Deadline

Confirm compliance within 48 hours of receipt. If Meta continues to host these publications after notice, I will proceed on the basis that Meta is knowingly facilitating ongoing republication and I will preserve all rights to seek further relief and damages.

What happened

On 25 Oct 2025, Joel Walker published a Facebook group post that makes a false criminal allegation about me and identifies my business, "Legion Killfeed". He then edited the same post to add my name and business, which republished the allegation to the same audience. The same account later posted substantially similar statements that again name my business.

Why removal is required

The statements are false, identify me and my business, and allege serious criminal conduct. This is unlawful in my jurisdiction under the Defamation Act 2005 (NSW) as amended 2020 section 12A and is causing ongoing harm to my reputation and business.

Prior notice to Meta

Your support already placed Meta on notice and provided me reference 1332648995224789. I supplied the same URL and context. Since the report flow did not offer a defamation option, I am escalating here and requesting Legal review.

Requested actions

Remove the above post and any edited or derivative versions that carry the same defamatory imputation and identify "Legion Killfeed".

Remove reposts, stories, previews, and cached renders that duplicate the text.

Treat any further edits or reposts from this publisher as republications after notice.

Place a litigation hold on all internal notes, moderation logs, edit histories, analytics, and related telemetry for the post, the group, and the publisher account.

Confirm removal in writing and provide a named point of contact for follow up.
