Dear Abhishek,

Are you mentally impaired? Do you know how to read English correctly?

Your response completely misses the point. Simply explaining Trustpilot's general review-detection process and warning about the flagging tool does nothing to address our concerns or the evidence we provided. Jovin asked for specific proof of the issues I raised, and I supplied detailed documentation. Asking me to resend files in a certain format (PDF, JPEG, etc.) is irrelevant at this stage – we already provided the evidence in appropriate formats. That “formats” request does not excuse your failure to engage with the actual substance of my complaints. In short, you have not even acknowledged the substance of what we asked you to review.

I have now attached additional proof (three videos) clearly showing reviews and posts that you said were removed, which are in fact still publicly visible. Each video is a screen-capture demonstrating that Trustpilot (as well as Facebook, Reddit, and Discord) left up defamatory content despite our notice. The burden is not on me to reformat or resend evidence ad infinitum – your team has had ample opportunity to examine our materials, and these videos are just more irrefutable confirmation of the same problems.

This campaign of harassment and slander across social media has wreaked havoc on my business. You will recall that between July and September 2025, coordinated attacks on Facebook triggered a wave of fake one-star Trustpilot reviews, and synchronized posts on Reddit and Discord echoed the same false accusations. The financial impact has been devastating. As documented in our records, Legion Killfeed's monthly revenue halved in this period – dropping from about \$1,200 in May 2025 to roughly \$526 by September 2025 – and our subscriber base plunged from 139 to 72 active users. One particularly egregious fake review (“ABSOLUTE SCAM”) alone caused 23 paying customers to cancel their subscriptions overnight. In short, nearly half of our customers and over half of our income vanished almost immediately following these defamatory posts. These figures come directly from our business accounts and transaction logs, and they correlate exactly with the timing of the attack coordinated on your platform and others.

The role that Trustpilot, Facebook/Meta, Reddit, and Discord played in this cannot be overstated. These platforms became a megaphone for lies about me and Legion Killfeed. On Facebook, malicious users openly incited others to post fake negative reviews and even filed baseless chargebacks, directing traffic to our profile. Discord moderators repeatedly ignored or even punished me for defending myself against doxxing and harassment, while Reddit simply let slanderous threads proliferate unchecked. Throughout this period I informed Trustpilot over 300 times (via emails and flag submissions) about the false reviews and slurs on all these sites. I even provided full logs and proof that the so-called “reviews” came from competitors or impostors. Yet your team consistently refused to act on that evidence – often reinstating or declining to remove reviews that we had proven were fake and defamatory. It took months of legal pressure just to get you to finally remove the content, and even then only after I threatened formal legal action.

All of this happened after I gave every platform – including Trustpilot – a fair chance to fix the problem. On August 10, 2025 I served a comprehensive cease-and-desist notice and legal demand listing each defamatory review (with attachments proving their falsity). Trustpilot's response was not to correct its mistakes, but to label me a “misuser” of the flagging tool as soon as possible. Even after that, your team did nothing substantive. Instead you sat on our evidence, asked for files in different formats, and filled our inboxes with boilerplate explanations about your automated detection systems. None of these evasive tactics changes the fact that Trustpilot has published blatantly false statements about my company – statements that you knew or should have known were not true. You had every opportunity to address these claims when we first raised them; your failure to do so has only multiplied the harm.

Now, due to Trustpilot's continued inaction and negligent enforcement of your own policies, I have begun the process of

retaining legal counsel. We will pursue claims against Trustpilot, Meta (Facebook), Reddit, and Discord for defamation, negligence, and violations of consumer-protection and data laws. Under Australian and UK law (for example, Fairfax v. Voller in Australia) every republication of a defamatory statement after notice is treated as a new act of defamation – meaning each time your platform allowed or even reinstated a review after being told it was false, Trustpilot became freshly liable for it. Similarly, the EU's Digital Services Act (DSA) and various consumer laws impose strict duties on platforms to promptly remove illegal content once they are on notice. Trustpilot has repeatedly ignored those duties. We are confident the law is on our side. The pattern of egregious conduct here – bots and impostors producing fake reviews, paid subscribers filing frivolous disputes, coordinated doxxing and personal slander – all facilitated by these platforms, has caused "serious harm" well above any statutory threshold. The damage to my business's reputation and bottom line is fully documented and, frankly, catastrophic. In fact, my October 5th communication (attached) outlines how Trustpilot's own records confirm this pattern: hundreds of ignored complaints, systematic bad-faith moderation (e.g. the reinstatement of proven fake reviews immediately after I pointed them out), and the extreme financial impact on Legion Killfeed. All told, the defamatory campaign across Facebook, Discord, Reddit and Trustpilot destroyed nearly half of our customer base and more than 50% of our revenue within a few months. That level of harm easily exceeds the legal standard for defamation and consumer-protection damages.

Given this reality, legal consequences are inevitable. I've even had AI review every piece of evidence and it believes this could become a landmark case regarding platform liability and the DSA's obligations. We will seek full compensatory and aggravated damages (including our legal costs) in court. I have already started preparing the documents to pursue enforcement through regulators like notifying the UK Competition and Markets Authority, the Australian Competition and Consumer Commission and eSafety Commissioner, EU DSA authorities, and any other relevant body of Trustpilot's repeated failures. I advise you to start taking this seriously and have a senior staff member take over if you're too incompetent to read correctly. If this makes it to court, I won't be going just for compensation. I will be fighting for a change so no one else has to go through so much bullshit just to get something that is absolutely a violation of your Terms of Use and all that shit. I'm so over it I don't give a shit that I'm swearing in this shit anymore, just pull your head out of your ass and do your job within the law.

There was over 300 emails between Trustpilot and myself for the month of August alone, drop the feigning innocent bullshit or go get Jovin to taken over. At least he was willing to read my emails.

In summary, we are done waiting while our evidence is dismissed and our business is ruined. We have provided you with every piece of proof you asked for (in the required formats). There is no reasonable excuse left for your inaction. Trustpilot and the other platforms had ample opportunity to fix this amicably; now our attorneys are standing by to ensure each party is held fully accountable. I hope you will finally choose the reasonable path here and resolve this matter immediately. If not, trust that we will see you in court very soon – with all the evidence laid bare.

We understand your concern regarding the "misuse of the flagging tool."

We want to clarify that businesses are warned if they flag a large number of negative reviews inappropriately.
