Please provide any additional information that can help us understand your report. : I am Anthony Brodie ("Soul"), the owner of Legion Killfeed. The reported post is here:

It contains a false criminal allegation presented as fact: "Soul from legion Killfeeds a pedo." I have never been charged with or investigated for any such offense. This is a targeted defamation that identifies me by name and business and is causing serious harm to my reputation and safety.

The group administrator, Joel Walker edited a previous post that had 71 likes to make it seem like there was support behind it. The content directly states "Soul from Legion Killfeed is a pedo" and how your ridiculous AI hasn't picked up on it yet is baffling.

The group administrator, Joel Walker, edited an earlier version of the post that already had reactions so it appears that the defamatory statement had prior support. The edit history shows two versions on 25 Oct 2025 with different reaction totals, and the later version adds the line naming me. Please review and preserve the edit history, version logs, and admin actions for this post.

The comments thread shows escalations and calls for violence directed at the target of the accusation, which increases the harassment and safety risk. This violates Facebook's policies on bullying and harassment and on false criminal allegations.

I am located in Australia and assert my rights here. I request:

1) Removal of the post and any duplicates.

2) Enforcement action against the account responsible for posting and bumping it.

3) Preservation of logs, edit history, and reaction history for potential legal proceedings.

This is not an isolated incident. The group feed at:

<https://www.facebook.com/groups/makedayzgreatestagain>

shows a consistent pattern of posts that target named individuals and small businesses with insults, false criminal accusations, and dogpiling.

Please audit and preserve the last six months of content (approximately 02 May 2025 to 02 Nov 2025), including edit histories, reaction logs, and admin actions. You will see:

- Repeated attack posts using terms like "pedo" directed at specific people by name.

- Admin-authored posts and "bump" replies that keep harassment threads active to attract more abuse.

- Comment threads that escalate into calls for harm or violence toward the targeted person.

• Edits to older posts that reuse existing reactions to create the appearance of support for new defamatory claims. The overall purpose of the page appears to be attacking people rather than community discussion. Please review the group history, enforce the bullying and harassment policies, remove offending posts, and preserve all logs for potential legal proceedings.
