Third appeal. Competitor-driven harassment originating on Discord, spreading across four platforms, including suicide encouragements. Your enforcement targeted the reporting victim. Immediate human review required.

Hello Trust and Safety,

This is my third appeal. Tickets 61451498 and 61451749 were closed without any substantive review. The first was closed as "Solved" after a routing message. The second returned a canned account-standing notice that ignored the record.

Core facts that must be reviewed by a human

- The abuse is primarily from competitors and their associates. They used Discord as the launch point for a long-running campaign and then carried it to other platforms including Reddit. The objective has been to damage my business and divert customers. Names, handles, and user IDs are listed in my prior submission.
- The same actors coordinated defamation off-platform to amplify the Discord abuse and steer buyers away from my product. This is competitor activity, not organic criticism.
- Suicide encouragements and extreme abuse were directed at me. Discord did not act on those messages, yet you applied enforcement against me for a defensive reply to a harasser who re-contacted me from a new account to evade blocks.
- The strike now sits on my account until 2027. I was the reporting party. The harasser initiated contact after a prior block. My reply put them on notice to cease and referenced ongoing legal processes. That is not harassment.

What you need to review

- Full DM thread history including deleted messages
- Block and re-contact logs that show the new account used to evade prior blocks
- Linkage across the listed accounts associated with competitor operations and brigading

Requested actions

- Reverse the harassment/bullying strike and remove the account-standing flag
- Apply enforcement to the initiating account that block-evaded to restart contact and to any linked competitor accounts coordinating the campaign
- Note my account for ongoing targeted harassment to prevent reporter-retaliation in future reports
- Confirm in writing that a human reviewed the full DM context, block logs, and account linkages

Business harm

This campaign has diverted customers and damaged my reputation in a niche market. It is competitor-driven, began on Discord, and spread across four platforms. Your current enforcement rewards the aggressors, penalizes the reporting victim, and leaves a false flag on my account through 2027.

Legal and regulatory references for your consideration

- Australia | Criminal Code Act 1995 (Cth) s 474.17: using a carriage service to menace, harass or cause offense. Suicide-baiting and persistent harassment via online services are squarely within scope.
- Australia | Online Safety Act 2021 (Cth): Adult cyber-abuse scheme requires action against material that is intended to cause serious harm to an Australian adult.
- Basic Online Safety Expectations (BOSE) determination requires providers to have effective complaint handling and to take reasonable steps to minimize unlawful/seriously harmful material.
- Australia | Competition and Consumer Act 2010 (Cth) (Australian Consumer Law, Sch 2): I will be filing with the ACCC regarding competitor-led interference and misleading conduct arising from failure to address known abuse that harms a lawful business (including the effect of an inaccurate "account standing" signal).
- EU – Digital Services Act (Regulation (EU) 2022/2065) for your EU users:
 - Art. 14 notice-and-action obligations when users report illegal content,
 - Art. 16 internal complaint-handling with human review,

- Art. 20 measures against repeat offenders (e.g., suspending users who frequently post illegal content).
- UK – Online Safety Act 2023: duties of care for user-to-user services to mitigate illegal content and protect users, including content encouraging self-harm.

Escalation

Do not close this with routing advice. I already re-filed in the correct category and received a canned response. If you refuse to acknowledge the facts and apply policy correctly after a human review, I will file a formal report with the Australian Competition and Consumer Commission (ACCC) and notify parallel consumer and online-safety agencies internationally under the above frameworks. I would prefer Discord resolve this correctly without regulator involvement.

Please confirm the strike has been removed and that enforcement has been applied to the correct accounts.

Soul responds that all of them are toxic and “grouping up to do his bidding” and calls out UntoldTruthy and Josie specifically for siding with “a pedophile thief” despite knowing the truth. UntoldTruthy concedes that Soul sent him a lot of material and says “yes, I’m not gonna deny that, but I never looked at any of it.” Soul then posts a screenshot of an alt account and asks, “so that’s not you?”

At the very bottom of that conversation, next to UntoldTruthy's profile card (showing his name, tag, and "Member since Mar 3, 2018"), there is another message where he says he is not siding with anyone, that DayZ BoosterZ was a mutual party and they did not want to be involved, and that he only skimmed what Soul sent, never fully watching the videos or opening all the pictures. Under this, in big red letters, Soul's annotation says "USER ID: 419142702937014272" and "Confirms ban evasion on another alt."

Soul's red annotations throughout emphasise that despite all this, Discord's enforcement hit him with harassment and bullying strikes for defending himself or posting evidence, while the harassers and ban evaders were not removed.

This refusal—and the fact that Discord was repeatedly placed on notice—will be placed before regulators and courts as an aggravating factor.

1. Discord’s own policies contradict your current behaviour

Discord’s Investigation Policy

Discord states that when a user reports harassment, Trust & Safety will “look through the available evidence and gather as much information as possible” and investigate wider patterns, not isolated messages.

This is from your Safety Center article “How We Investigate,” which explicitly says Discord examines:

- full context
- patterns of behaviour
- associated networks, and
- that context can change the meaning entirely.

Your current ticket responses do not reflect this policy.

Instead, you have repeatedly responded with templates claiming you “cannot review screenshots, logs, or external evidence”—despite your own documentation requiring consideration of all available evidence.

Discord's Reporting & Safety Policy

Your "Reporting Content or Behavior to Discord" article confirms that harassment, hate speech, and coordinated abuse are lower-harm but still actionable categories, requiring human review, and may require weeks depending on complexity.

You have not conducted this review across any of the tickets listed.

Discord's Ban Evasion & Advanced Harassment documentation

Your own article on "Advanced Harassment" acknowledges patterns identical to the behaviour documented in my tickets:

- persistent harassment
- ban evasion
- re-contact from new accounts
- coordinated group abuse
- cross-platform spread
- attempts to punish the victim

You have been given direct evidence of this exact pattern across multiple individuals and platforms.

You have not acted on it.

Discord's Self-Harm Response Policy

Your policy states that Discord will investigate reports of self-harm threats and may contact authorities, and encourages users to report such content for review.
