Hello Trust & Safety,

This is now a formal escalation outlining systemic, documented misconduct by Discord in handling a long-running harassment campaign targeting me, my business, and my family. Your recent messages claiming you are “unable to use screenshots, bot logs, off-platform information, or attachments to verify content” directly contradict your own records, your own prior handling of my tickets, and your own data-export README.

Your platform has repeatedly enabled a coordinated group of competitors who have used Discord as the starting point of a harassment campaign spanning four years, across Discord, Facebook, Reddit, Trustpilot, and multiple impersonation websites. Discord has had this knowledge for years.

Your contradictions are now documented as follows:

- In my exported Support Tickets JSON, tickets 30339510 and 30414871 are labelled “SCRUBBED” with subject “deleted,” but the preserved contents show they were about one of the same harassers: Links (Mason Lewis Stockton), and his multiple alt accounts. Discord acknowledged the evidence at the time, thanked me for providing message IDs and screenshots, and told me to keep supplying them. Those tickets are now hidden from my visible history, while the same group continues and I am the one being penalised.
- Discord previously accepted screenshots and attachments from me to take action against that group, as shown in the 2023–2024 tickets included in my export. You did act on those past submissions. You cannot now claim those categories of evidence are unusable.
- Your own README.txt included with my data export explicitly states that manually deleted messages will not appear in my export and will not be available to me. This proves the in-app-only requirement is structurally incapable of protecting victims when harassers delete messages. You require victims to show messages you already admit you cannot and will not retain.
- The same actors listed in the 2022 and 2023 tickets reappear in ticket 61451749 (“I reported the harasser; enforcement was applied to me instead”) and again in my 2025 ticket chain. You have had a continuous, consistent record of this group for years.
- You now repeatedly close tickets with template text, even when the initiating message was reported in-app exactly as you instruct. Your replies ignore the block-evasion evidence, the re-contact from new accounts, the suicide-baiting, the sharing of my children’s images, and the false sexual accusations. You instead apply enforcement to the victim every time.
- The “we cannot use attachments or screenshots” claim is contradicted by your own internal history, your own instructions, your own past actions, and your own removal actions from 2022–2024. You cannot rewrite your procedure retroactively to blame victims for your moderation failures.

I now require Discord to escalate this to a human who can actually review the case.

You must acknowledge:

A. That tickets 30339510 and 30414871 were tied to this exact same group of harassers and explain why those earlier tickets

- were scrubbed from my visible history despite belonging to the same chain of abuse.
- B. That Trust & Safety is permitted to use screenshots and attachments when your own logs are incomplete due to message deletion. You have done so before. Your past actions confirm this.
- C. That my 2025 enforcements were incorrectly applied.
- i. The initiating message was reported in-app. The harasser evaded a previous block, re-contacted from a new account, and I responded with a lawful notice to cease. That is not harassment.
- ii. The reported message was one countering false claims of pedophilia against me. You took action against me for stating I am not a pedophile. You took action and silenced my account, interfering with my ability to run my business, for stating I am not a pedophile after one of the harassers altered a facebook post several hours after he originally posted it, to call me a pedophile and make it look like it had support. There is no evidence anywhere in the world to even hint I would ever touch children, other than on yours and Meta's platform, posted by the people you keep enabling.
- D. That the strike placed on my account until 2027 must be reversed, because Discord already held the Facebook evidence of the false pedophile accusations for four days before punishing the victim instead of the initiator.
- E. That your repeated refusal to even acknowledge the off-platform spread, despite knowing it was the same individuals, directly contradicts the Basic Online Safety Expectations which require you to take reasonable steps to minimise adult cyber abuse.

You now have direct legal exposure under multiple Australian regulatory schemes.

BOSE failure exposure:

Discord must take reasonable steps to minimise cyberbullying of children, adult cyber abuse, and non-consensual intimate image abuse. Discord must provide clear, effective complaint-handling pathways. Discord must respond fully, honestly and accurately to BOSE notices. A failure to comply carries penalties up to 500 penalty units for an individual and up to 2,500 penalty units for a body corporate. At the current penalty unit value of 330 dollars, that is up to 825,000 dollars per BOSE contravention.

Adult Cyber Abuse Scheme exposure:

Discord must act when notified of content intended to cause serious harm to an Australian adult. Failure to comply with a removal notice (Discord or end-user) is up to 500 penalty units per contravention (165,000 dollars) or up to 825,000 dollars for a body corporate.

Cyberbullying (children) scheme exposure:

Failure to remove cyberbullying material relating to Australian children within required timeframes is also up to 825,000 dollars per contravention for a body corporate.

Image-Based Abuse (IBA) scheme exposure:

Non-consensual intimate images (including deepfakes or threats) involving Discord’s hosting or failure to remove can attract up to 500 penalty units per contravention for individuals (165,000 dollars) and 825,000 dollars per contravention for Discord as a provider.

Discord is now repeatedly:

- Applying enforcement to the victim
- Ignoring prior knowledge of the harassment group
- Refusing to review DM threads, block-evasion logs, and linked accounts
- Requiring “in-app messages” they know will be missing because deleted messages are not retained
- Contradicting their own historical acceptance of attachments and screenshots
- Closing harassment reports with template text regardless of evidence

This is why your process is failing, and why this case is now being prepared for escalation to the ACCC, the eSafety Commissioner under BOSE, Adult Cyber Abuse, Cyberbullying, and IBA frameworks, and (if necessary) civil proceedings.

A human must now:

- Confirm the historical ticket linkage and explain the scrubbing of the early tickets.
- Confirm Trust & Safety can consider attachments and archived materials when your own logs are incomplete.
- Conduct a human review of the full DM thread history, block-evasion logs, and account linkages.
- Reverse the strike and remove the 2027 flag entirely.
- Apply enforcement to the initiating harassers.
- Annotate my account for long-running targeted harassment to prevent reporter-retaliation.
- Stop closing tickets with process-dodging templates. Your own data export proves those template responses are incompatible with your record-keeping, and your contradictions are now documented.

I expect an actual human review, not another automated dismissal.

Your response from “Usagi Tsukino” is not responsive to my ticket and will be relied on as evidence of Discord’s refusal to handle a serious safety and defamation complaint.

You have replied as if this is a new “report” that needs to go through the in-app “Report Message” flow. It is not.

1. The content I am complaining about was already reported in-app, exactly as your Safety Center instructs.
2. The ticket you have replied to is about:
 - Your repeated decision to apply enforcement to the victim rather than the initiating harassers.
 - Your refusal to consider evidence you have already been given in previous tickets.
 - Your contradictions between what your own export and README say you can see and what you now claim you cannot see.
 - The fact that you currently have a strike on my account until 2027 based on a response where I denied being a pedophile after being falsely accused.

Telling me to “submit a report via the Discord App” when this entire chain already arises from an in-app report is circular and dishonest. It is not complaint handling, it is process-dodging.

- You have already:
- Accepted screenshots, attachments, and detailed context from me in tickets 30339510 and 30414871 and related tickets.
 - Acted on that evidence in the past.
 - Admitted in your own README.txt that my export will not contain manually deleted messages, which means it is structurally impossible for a victim to rely solely on “in-app” message IDs where harassers delete content.

- You cannot:
- Encourage users to report in-app,
 - Admit that deleted content will not appear in exports,
 - Previously accept screenshots and attachments as necessary context,
 - Then suddenly claim you “cannot use screenshots, bot logs, off-platform information, or attachments” and close the ticket.

I will be very clear:

This ticket is a complaint about your *handling* of my prior reports, your failure to address a four-year harassment campaign that includes suicide encouragement and false pedophile accusations, and your misapplication of enforcement to me. It is not a fresh abuse report. Sending me back to the same in-app flow is a refusal to address the complaint.

- You are now on notice that:
- Closing this ticket again with the same template, without a human review of:
 - the tickets listed at the top of my original message
 - the relevant DM threads
 - the block-evasion and re-contact patterns
 - the off-platform spread that you were specifically notified about

will be treated as:

- A. A refusal to comply with the Basic Online Safety Expectations that require you to have effective complaint handling and to take reasonable steps to minimise adult cyber abuse.
- B. A refusal to correct a known error where enforcement was placed on the victim (me) for denying false pedophile allegations, while the initiators continue to use your platform and others to escalate harm.
- C. Evidence that Discord, fully on notice of the specific URLs, accounts, ticket numbers, and cross-platform spread, chose to hide behind a process script rather than engage with the substance.

I again request and require that:

1. This ticket be escalated to a human in Trust & Safety with authority to review historical tickets and attached evidence.
2. You confirm that Trust & Safety *is allowed* to consider screenshots, archived logs, and off-platform material where your own logs are incomplete due to deletion.
3. You conduct a human review of the accounts already identified across the listed tickets, including block-evasion patterns, and apply enforcement to the initiating harassers.
4. You reverse the strike and remove the 2027 flag from my account.
5. You annotate my account for long-running targeted harassment so that future reports are not turned back on me.

If you decide you are simply not going to handle this complaint, then state that explicitly in writing. Closing this ticket again with the same boilerplate will be treated as clear evidence for the eSafety Commissioner, ACCC, and any court, that Discord refused to examine the evidence while fully on notice of the ongoing harm.
