**Subject: Escalation, ongoing harassment and risk of serious self-harm - ACA-2024-0528878 [SEC=OFFICIAL:Sensitive] CRM:0151474**

Hi Ash,

I'm writing to follow up on the matter below (ACA-2024-0528878). It has now been well over a year since that complaint and things have not improved. They have escalated to the point where the ongoing harassment and repeated platform failures are causing me active suicidal ideation.

To be clear:

I am 32 years old, I do not want to die, and I do not want to be in a position where I feel forced to talk about killing myself just to get anyone's attention. But after three years of coordinated harassment and being ignored or punished by the platforms I report to, that is where this has ended up.

Since your last email:

- I have been continuously targeted across Facebook, Reddit, Discord and Trustpilot with posts and reviews falsely calling me a pedophile and a scam, and attacking my business and reputation.
- Meta made me sit in a support chat for more than 12 hours and then did nothing – none of the posts falsely branding me a pedophile or a scammer were removed.
- Discord has punished me twice: once for responding with strong language to a harasser who was already on their fourth account ban-evading, and again simply for posting links to documentation that disproves the pedophile accusations:

- Trustpilot is now hosting multiple blatantly defamatory reviews that are clearly part of the same campaign. Even when I provide detailed evidence and context, they either do nothing or quietly edit around the worst parts while continuing to publish the rest.

I have followed every process I have been told to follow:

- I documented everything.
- I reported content through each platform's internal tools.
- I lodged complaints with your office when platforms failed to act.

The net result is that the people targeting me remain online and active, my name and business are still being smeared publicly, and the only person who consistently gets sanctioned is me, when I finally crack under three years of nonstop abuse.

I need to be blunt: if a “semi-well adjusted” adult with long experience around serious mental illness can be pushed to genuine suicidal thinking by this, I have no idea how a teenager or a more vulnerable person is meant to survive it. If the only thing that gets any reaction is me saying “I’ll kill myself,” then the system you’re asking people to use is actively dangerous.

I am asking for this case to be properly escalated as what it is: a sustained, multi-platform harassment campaign that has already driven a complainant into suicidal ideation after he did everything he was told to do.

Specifically, I am asking that you:

1. Re-open and escalate ACA-2024-0528878 in light of what has happened since your last email.
2. Engage directly with Discord, Meta and Trustpilot using your statutory powers, with a focus on the pattern of behaviour and not just single messages.
3. Explain what concrete protections your office can actually provide when a complainant is being pushed into suicidal thoughts by ongoing abuse that has already been reported multiple times.

I am not asking for sympathy. I am asking for your office to do the job it was created to do: intervene where platform processes have clearly failed and where the risk of serious harm is now obvious and documented.

It includes screenshots, logs, tickets, emails and videos showing the ongoing harassment and the repeated failures of each platform’s internal reporting systems.

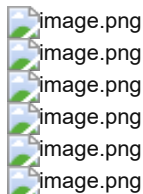

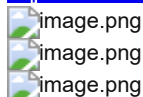

Hi Anthony

We're sorry to see you being targeted by this abuse. We strongly encourage you to disengage from this group though, block any people targeting you with abuse and no longer engage. Responding or replying to abuse can inflame the situation.

We noted you reporting the image of you and your children to Discord as well as the posting of your address. If the material is still online tomorrow and Discord don't act on your report, you can send us message links to the comments and we'll assess if we can act on it under our powers.

Again, we're conscious there's clearly a complicated history with some of the people in this group (and they may be related to your concerns about intellectual property theft) but sometimes, when things get toxic it's best to just walk away and not let people like this be a negative influence in your life. It was clear from the chat samples you sent that these people know how to push your buttons and they were clearly motivated to go further by your responses.

We hear this has had a big impact on you and the issues about how you have been wronged go deeper than eSafety can assist with.

If you would like, we can ask for a counselling service to call you to talk to you about what's going on and help support you. We have an arrangement with the counselling service YourTown where they provide free short-term counselling to clients that we refer to them.

If you are interested in this service, please let us know by replying to this email with your contact number and preferred contact times.

If we receive your consent, we will contact YourTown to let them know what's been going on for you and pass on your details. They will usually give you a call within a day or two and may call from a private number.
