Subject: Re: Privacy rights request – obstruction and refusal to action AI at Meta objection

Hi Privacy Operations,

Thank you for your reply. Clearly you are one of the inferior employees who refuses to read.

I am now on my third round of almost identical template responses that do not address my actual privacy rights request.

1. I first submitted a **Deletion** request through your own **AI at Meta** form.
2. You replied under the heading “How Meta uses information for generative AI” and treated it as an AI at Meta request.
3. I clarified that I was exercising my rights to object to the use of my data for AI training and to request deletion or effective exclusion from your AI training datasets.
4. You then replied again with another AI at Meta template, confirming you use information from third parties and from Meta products to develop and improve AI at Meta, and told me to log in and re-submit through product specific forms.
5. Now you are telling me, yet again, to go back to a generic “Privacy rights request” page and pick a different product.

This is not a product confusion issue. It is one rights request that cuts across both:

- AI at Meta training that uses information from **third parties**, and
- AI at Meta training and profiling that uses information I have provided or generated on **Meta products and services** such as Facebook.

You have enough information in this ticket to understand and action that request. You have my name, email, region and the nature of the objection. You have already identified which internal product teams are involved because you have already sent me AI at Meta specific templates.

I am therefore putting this as plainly as possible:

1. This email is a valid exercise of my privacy rights

Under applicable data protection and privacy law, I am not required to use your preferred web form in order to exercise my rights. An email to your designated contact address that clearly sets out my request is sufficient.

I again confirm that I am exercising my rights:

- To **object** to the use of my personal information, whether obtained directly from me on Meta products or from third parties, for training, fine tuning, evaluation or improvement of **AI at**

Meta models and features.

- To request **deletion or effective exclusion** of my personal information from AI at Meta training datasets, evaluation sets, AI specific “memories” and profiles, to the extent technically possible.

You have now received this objection multiple times in writing. You are on notice and you must treat it as such.

2. Your obligation is to route the request internally, not to send me in circles

If parts of my request need to be handled by different internal teams (for example, Facebook account level data vs AI at Meta training corpora) then that is an internal routing issue for Meta, not a reason to reject or ignore the request.

I am not refusing to verify my identity. If you need specific account identifiers to match this ticket to my Facebook or Instagram accounts, you can request them directly in your reply and I will provide them. What I am not willing to do is have my request repeatedly discarded and turned into a requirement that I start over with a new form each time.

Please confirm that:

1. This email chain will be treated as a valid privacy rights request for all Meta products and AI at Meta processing linked to my identity.
2. You have recorded my objection to the use of my data for AI training and will stop using my content and interactions as training data except where strictly necessary to provide the immediate service requested.
3. You will take reasonable steps to remove or effectively exclude my personal information from AI training datasets and AI profiling systems, to the extent technically possible.
4. You will provide a substantive written explanation of what categories of my personal information have already been used for AI at Meta and under what legal basis.

If you refuse to accept this email as a valid request, please state that explicitly in writing and explain the legal basis on which you believe you can require the use of your proprietary web forms as the only channel for exercising statutory privacy rights.

3. Escalation

Unless you provide a clear, substantive response to the points above, I will treat this as deliberate obstruction of a privacy rights request. I will refer this full correspondence, including the repeated template deflections, to the relevant regulators, including the Office of the Australian Information Commissioner and any applicable EU supervisory authority.

P.S. As already explained, your services are continuing to host and republish serious defamation about me that I have repeatedly reported. In the “DayZ Console Community” and related groups, Joel Walker has posts that explicitly name me and my business and state that “Soul from legion Killfeeds a pedo,” that I “smoke meth on the regular,” that I abuse family members, and that I sabotage other communities’ servers. Some of these posts use Meta AI generated backgrounds

and carry the Meta AI mark. You have reviewed these reports and replied that they do not violate your Community Standards, so you are now knowingly continuing to publish these false and highly damaging allegations. That ongoing publication is itself processing of my personal information and will form part of my complaints to regulators alongside your refusal to properly handle this AI at Meta objection and deletion request.
