Hi Privacy Operations,

Thank you for your reply.

Your message appears to do two things:

- It claims that any personal information about me that you obtain from "third parties" for AI training is not stored in a way that lets you identify which information belongs to which person, so you will not allow access, correction or deletion in relation to that data.
- It redirects my objection to the use of information I have shared on Meta products and services to a series of in-product forms that I must complete again after logging in.

I want to be very clear that neither point resolves the request I already made.

1. Use of "information from third parties" for AI training

You confirm that you ingest "publicly available on the internet" information and licensed information from others as training data for AI at Meta. You also accept that this may contain personal information.

My request is not about whether you have designed your internal systems in a way that makes it inconvenient for you to map a particular entry in a training dataset back to an individual. It is about the fact that you are processing my personal information for AI development and improvement at all.

I am again stating that:

- I do not consent to you using any personal information about me, whether obtained directly from me or from third parties, to train, fine tune, evaluate or otherwise improve AI at Meta models or features.
- I object to any such processing and I am exercising my rights under applicable data protection and privacy laws (including the Australian Privacy Act 1988 (Cth) and, to the extent that EU data protection law applies to the "EU" region you assigned to this request, the GDPR) to require you to stop such processing and to delete or effectively exclude my data from your AI training datasets and AI "memories" as far as technically possible.
- The fact that you have chosen to aggregate or pseudonymise data for training does not remove the personal nature of that data, nor does it extinguish my ability to object to this kind of processing. You are now on explicit notice that I do not want my data being used in this way.

If you are going to maintain the position that you will not allow any effective way for me to opt out of the use of third party personal information about me in AI training, please state this clearly and in writing, together with your legal reasoning, so that I can provide that to the relevant regulators.

2. Information I have shared on Meta products and services:

You also indicate that you "are keen to take action" on my objection to the use of my information from Meta products but require me to log in and resubmit the request through separate product-specific forms.

To be absolutely clear:

- You already have my full name (Anthony Brodie) and my contact email (asoulofone@hotmail.com) in this ticket.
- I have active Meta accounts, and you are in a better position than I am to associate this ticket with those accounts internally.
- I am willing to complete in-product forms if you insist, but that requirement can only be about identity verification and routing, not a way to avoid dealing with the substance of my request.

Accordingly, I ask you to:

- Treat this email chain itself as a valid exercise of my rights in relation to all Meta products and services linked to my identity, including but not limited to Facebook accounts, Instagram accounts and any Meta AI surfaces.

Confirm that you have recorded an objection to the use of my data from Meta products and services for AI training and improvement, and that you will:

- Stop using my existing and future content and interactions as training data for AI at Meta, except where strictly necessary to provide the immediate service I requested, and
- Delete or otherwise effectively exclude my data from your AI training datasets and AI specific profiles or "memories", to the extent technically possible.
- Explain, in plain language, which categories of my personal data you have already processed for AI at Meta and under what legal basis, so I can understand the scope of what you have done with my data so far.
- If you require any specific additional information to verify my identity for this purpose (for example, confirmation of account names or links to my profiles), please ask for that explicitly in your next reply rather than simply redirecting me to generic public forms.

3. Escalation

Unless and until you confirm in writing that:

- My objection has been fully recorded and respected for both "third party" data and data from Meta products, and
- Reasonable steps have been taken to remove or effectively exclude my data from AI at Meta training and associated profiling,
- I will treat this as an unresolved privacy complaint. I reserve the right to forward your responses and the underlying evidence to the relevant regulators, including the Office of the Australian Information Commissioner and any competent EU supervisory authority.

P.S.

As already explained, your platforms are continuing to host and republish very serious defamation about me that I have repeatedly reported. For example, in the "DayZ Console Community" and related groups, Joel Walker has posts that name me and my business and state that "Soul from Legion Killfeeds a pedo", that I "smoke meth on the regular", that I abuse family members, and that I sabotage other communities' servers. Some of these posts even carry the "Meta AI" mark on the generated backgrounds. You have reviewed these reports and responded that they do not violate your Community Standards, which means you are now knowingly continuing to publish them after notice. That ongoing publication is itself a form of processing of my personal information and is highly relevant to my objection: you are attempting to expand your use of data for AI training and profiling while refusing to remove clearly false and extremely damaging allegations about me that appear on your own services.

I'm still coming for you legally for defamation that cost me 50% of my customers, the defamation you allowed to stand, travelled across four platforms, all were put on notice. Reddit, Trustpilot, Meta & Discord continuously allowed defamation against my business that lead to dogpilling, suicide encouragements, content targetting my minor children, effectively ruining my reputation and your lazy use of AI combined with incompetent staff who left me waiting in a chat for 12 hours just for them to silently leave will be relied on in court to justify harm, for full clarity of your staff's incompetence, one of them called me despite my repeated objections to a call, I recorded the call where she clearly demonstrated she had not read a single thing before getting on a call, immediately after getting on a call she wanted to remote access my computer and never once said why. Then when asked I told the cunt that she did not need to access my computer to look at a post where a piece of shit keeps posting calling me pedophile and stating blatant lies about my business with the sole intent of causing harm. Your idiot staff have put you in a lot of hot water already, don't start jerking me around about my clear and legal objection to AI processing anything about me or my business for any training purposes.

You shouldn't play with AI when you can't even get a simple script to detect "XXXX XXXX is a pedophile" or "XXXX XXXX is a kiddy fiddler" and shit like that.

If your developers put the same level of work into the AI as they have the flagging system, you'll probably end up in prison in 6 months. That's just a personal opinion based on experience both writing auto moderation programs and being stuck having all my customers detered because your programmers can't write a simple keyword algorithm and keep allowing defamatory posts with no regard for my safety.

When we do get personal information as part of this information from third parties, we don't specifically link it to any Meta account, and the information is not stored in a way that allows Meta to identify which information belongs to a particular person. This is why we don't provide the ability to access, download, correct or delete your personal information from third parties that may be used to develop and improve AI at Meta.

However, if you have an additional concern about your personal information being included in a response from an AI at Meta model, you can let us know by responding to this email.

We're looking into your report, and it looks like you would like to object to Meta using the information you've shared on our Products and services to develop and improve AI at Meta.
