Re: Case 7-4274000039113 (Defamation delisting request)

Hello Google Legal Team,

I am replying on the same thread with the exact Google Search result URLs you requested (right click result title, "Copy link address"), and with the supporting PDFs attached.

Attachment resend due to size failure

My previous reply failed to send due to attachment size. The PDF "2025-12-22-google-take-down-7-4274000039113.pdf" is my last attempt at replying, originally it included an attachment MP4 ("2025-12-22-dmca-rick-rolled.mp4"), which appears to have triggered the size limit. I am resending that same email as a PDF attached as it details the harassment context further.

1. Entity clarification (Sole trader, not a corporation)

I am Anthony Gordon Brodie, an Australian Individual/Sole Trader (ABN 28 387 377 607). There is no company registration, no ACN, and no issued shares. I have attached the Australian Business Register (ABR) extract confirming:

- Entity name: BRODIE, ANTHONY GORDON
- Entity type: Individual/Sole Trader
- ABN status: Active from 24 Apr 2022
- Main business location: NSW 2541
- GST: Not currently registered

Accordingly, the following items from your requested list are not applicable and cannot be produced because they do not exist for a sole trader:

- "Corporation's full legal name, jurisdiction of registration, and registration number (e.g. ACN)"
- "Government record showing issued shares and identity of owners"
- "List of other corporations in which this company holds shares"
My business is owned solely by me, has no shares, and holds no corporate interests.

Employees: I operate as a sole trader. There are no employees other than myself (and any ad hoc contractors if and when engaged).

2. Standing (individual targeted)

The content identifies and targets me personally (including by the name "Soul") alongside my business name "Legion Killfeed". This is not only a "company complaint". My personal legal rights and reputation are directly affected by the publications.

3. Proof of requesting removal from the website owner and their response

You requested "documented proof (screenshots of an email will suffice) confirming that the company has asked the owner of the website in question to remove the content" and owner's response or a statement that the owner declined or did not respond".

For Reddit (owner/platform operator of the URLs listed below):

- I submitted a formal removal request to Reddit Legal Support regarding the defamatory thread and comments.
- Reddit refused to action the report (or stated they were not processing it).
I have attached the PDF containing my request to Reddit and their response/refusal.

For competitor-run websites (skynetvslegion.com and agpropvp.com):

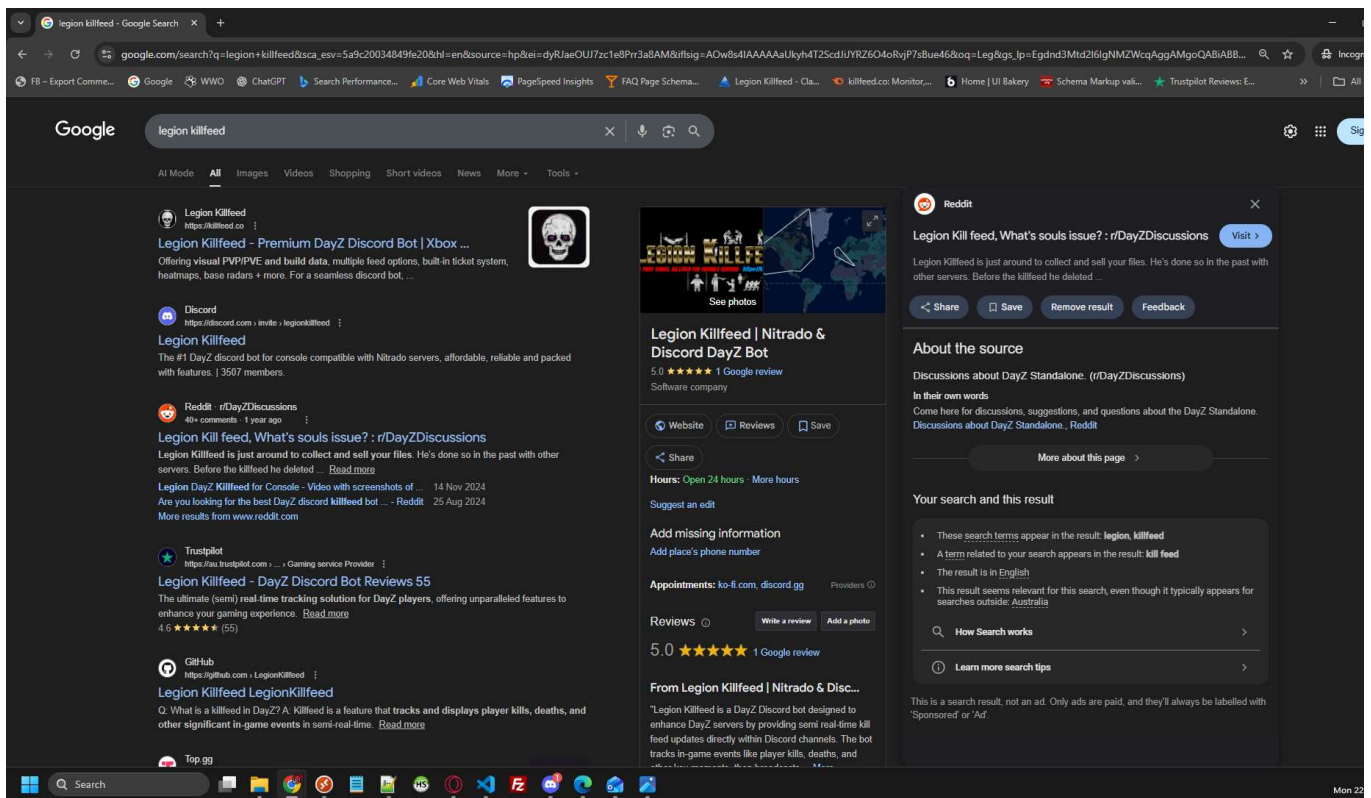
- These domains are part of the same competitor-driven campaign described below.
- There is already copious evidence of my direct requests to the owners, hosts, and registrars of these domains asking for removal of the defamatory material. Those communications and responses were included in the earlier email that failed to send due to size constraints.

5. Why these URLs are defamatory and why harm is ongoing

The Reddit thread and competitor sites publish false factual claims about me and my business, including allegations of criminal conduct (fraud), technical sabotage, an misuse of customer data. These are not opinions or fair comment. They are presented as factual allegations, and they have caused substantial reputational and busine harm.

The harm is ongoing and amplified because these URLs are prominent in Google Search results for "Legion Killfeed" (currently appearing near the top results in Australia as in my screenshot evidence).

6. Broader context (competitor-driven, cross-platform harassment)

This is not isolated criticism. It is a sustained campaign by competitors and their associates, propagated across:

- Reddit (defamatory thread and comments),
- competitor smear websites (skynetslegion.com and aggropvp.com),
- Facebook/Meta (republishing of serious false allegations), and it has escalated beyond commercial disparagement into harassment and safety risk. I have reported these issues to platforms and regulators. Key evidence is incl in the attached PDFs.

7. Request to Google

Please do the following:

A) Confirm you will evaluate this as an individual defamation delisting request (Anthony Gordon Brodie, identified as "Soul"), not as a "company only" complaint.

B) Proceed with delisting assessment for the URLs listed in section 4.

C) Confirm in writing that corporate-only documentation requests (ACN, issued shares, corporate holdings) are not required where the affected entity is an Individual/Sole Tra and confirm what you require instead (for example: ABN record plus a statutory declaration).

D) Provide the correct Google process or contact channel to report suspected abuse of legal processes and fraudulent DMCA claims being used as part of this campaign (incl whether any DMCA notices have been submitted to Google products referencing my domains, content, or media).
