Thank you for confirming your decision and removing the review by Edward Anthony Griggs Jr. from my Legion Killfeed profile page.

Two important follow-ups:

1. Please confirm whether this removal is global (not just hidden from the profile page)

Your email says you removed it because the reviewer "hasn't updated their review", however I also received Trustpilot's automated notification that this reviewer updated the content the same day. Either way, I appreciate the removal, but I need clarity on whether the review is fully removed or only de-listed from the profile.

2. The same attacker's content remains live on my DayZ Multi Tool profile

Edward's "attack" appears to be removed from Legion Killfeed, but his near-identical narrative is still visible on my DayZ Multi Tool profile ("Serious Security and Trust Concerns" by the same person). Please apply the same action there and confirm once complete.

Why this matters (the broader coordinated attack)

This review activity is not isolated "feedback". It is part of an ongoing, cross-platform harassment campaign that escalates whenever I speak publicly about my experience or report content. The latest round included coordinated social spam and brigading attempts (Facebook and Trustpilot), consistent with the pattern I've documented in prior communications to Trustpilot.

Hooded_saw review (non-customer) — direct quote from the review itself (already in my previous communications with Trustpilot)

A separate example of this coordinated behavior is the "Consumer" / "Hooded_saw" review, which includes statements like:

"Ps. The response you will find below is truly false. I have not and never will subscribe to this disgusting man. All he seems to have is child like, violent demeanor."

and

"You made a separate channel calling me names such as moron, imbecile and idiot."

This reviewer is not a genuine customer, and the review itself admits they have not subscribed, while still publishing defamatory character attacks.

Request

- Please confirm whether Edward's review is fully removed (not merely hidden from the profile page) and whether it remains accessible by direct URL.
- Please remove Edward's attack from my DayZ Multi Tool profile as well, and confirm once actioned.
- Please confirm what action will be taken on the "Consumer / Hooded_saw" review, given it is not based on a genuine experience and contains direct defamatory statements.
