Hello Trustpilot Support,

I am challenging the removal of my review of bigfatmods.com. The review is based on a genuine and well-documented experience with BIGFATMODS as an online service/community operator.

This experience does not involve a traditional checkout receipt, but it does involve direct, repeated interaction with the business and its operator. That interaction is the "service experience" my review describes, and it meets the threshold of a genuine experience for an online/service-based business.

Evidence of genuine interaction includes:

- Repeated, timestamped comments and replies directed at me by BIGFATMODS (and related accounts) across Facebook and TikTok.
- Accounts operating under the names "BIGFATMODS" and "Crix Madine Jr", which are controlled by the same individual (Edward Anthony Griggs Jr.).
- Public statements made by those accounts about my business/service, including adversarial exchanges connected to this dispute.
- Platform notifications, comment histories, and engagement/insights showing sustained interaction over time.
- Evidence of alternate accounts continuing engagement after moderation/reports.

These interactions were direct, service-related, and adversarial, and they formed the basis of my review. This is not hearsay, impersonation, or third-party commentary. It is my firsthand experience dealing with this business and its representative.

I am ready to provide supporting documentation, including:

- Screenshots of the comments/replies (with timestamps and profile identifiers visible)
- Profile pages and handle history linking the aliases to the same operator
- Platform notification logs
- Engagement analytics/insights confirming interaction

Additional context relevant to motive/retaliation:

Following my publication of feedback, two retaliatory 1-star reviews were posted about my business/tool on Trustpilot by Edward Anthony Griggs Jr. (titles: "Serious Security and Trust Concerns" and "Unprofessional, misleading, and harmful behavior"; the latter shows reference number 1189203064536703009). This pattern is consistent with retaliatory reporting/flagging behavior rather than a genuine dispute about whether I interacted with the business.

Please reassess the removal of my review in light of the above and advise where you would like the documentation submitted (reply to this email is fine unless you prefer an upload link). If you have specific requirements for what you need to verify an online/service experience, please list them and I will provide them.

Serious Security and Trust Concerns

I'm leaving this review due to serious concerns about this bot and the individual behind it. There is a well-documented pattern of discussions across the DayZ and Discord communities regarding this tool being linked to exploitative behavior, including actions that have resulted in Discord servers being compromised or wiped.

In addition to the technical concerns, I've personally been subjected to ongoing harassment connected to this project, which shows a complete lack of professionalism and accountability. When a developer behaves this way, it raises major red flags about trusting them with administrative or bot-level access to a server.

Server owners should think very carefully before giving this tool any permissions. Trust, transparency, and respect for community safety are critical — and based on my experience, this product and its operator do not meet those standards.

Over an extended period of time, I and several others in the DayZ community have been targeted with false and fabricated allegations that are being publicly spread online. These claims include manipulated or altered screenshots and completely untrue narratives that have caused real stress and disruption within the community.

Instead of resolving disputes professionally, this individual has chosen to publish defamatory content on external websites and social platforms, attempting to damage reputations rather than operate a legitimate service. None of the accusations being circulated are true, and no credible evidence has ever been provided — only edited or out-of-context material spanning several years.

This behavior raises serious concerns about ethics, trustworthiness, and professionalism. A service provider in this space should focus on stability, support, and community building — not harassment, false narratives, or intimidation tactics.

Based on my experience, I would not recommend using this service. There are far more reliable and professional alternatives available that do not engage in this kind of conduct.

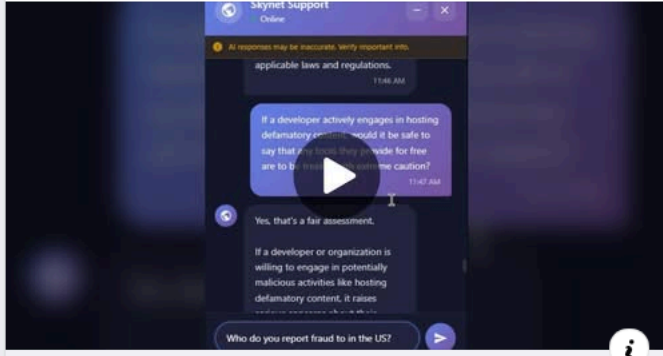

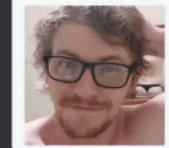

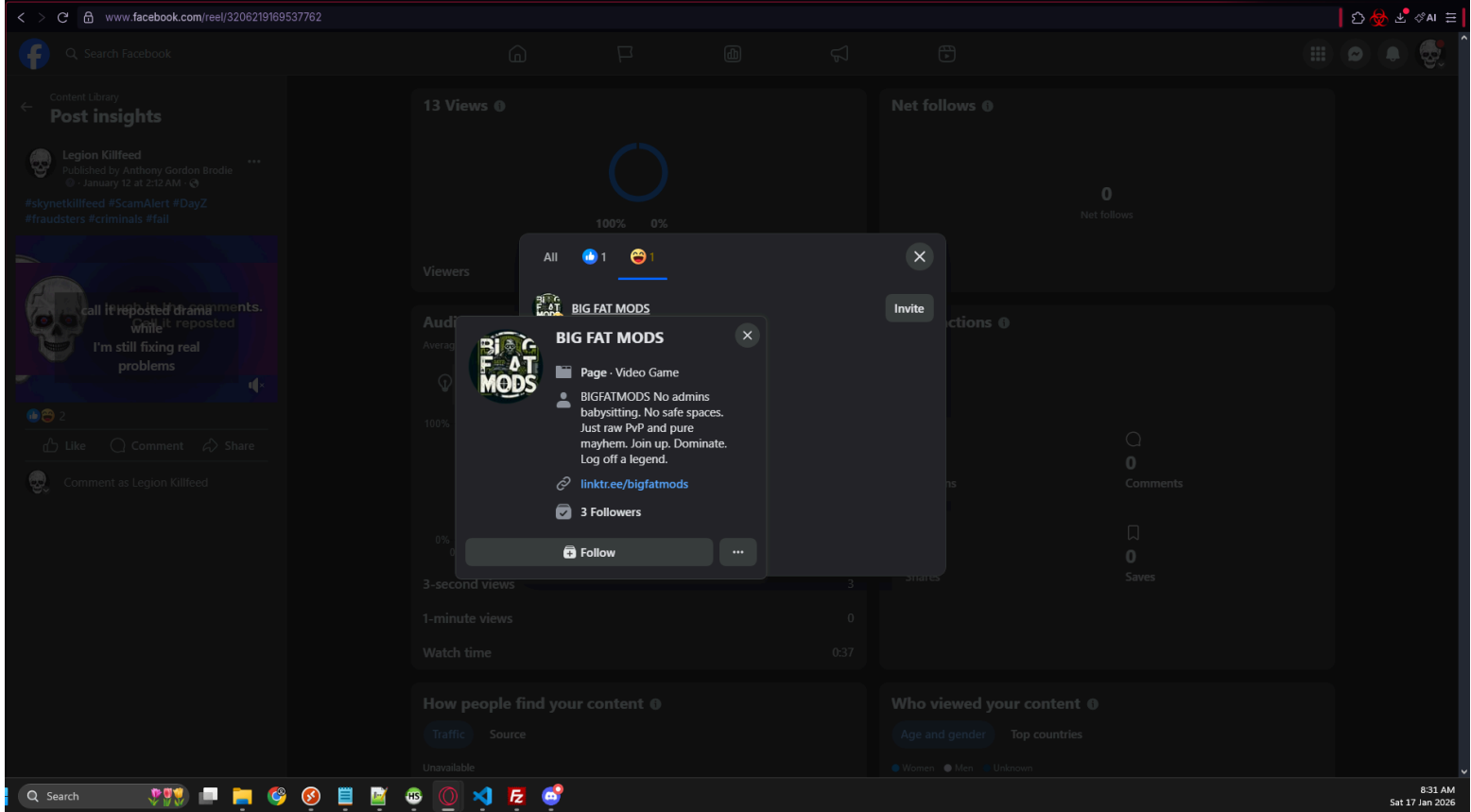
