Hello Google Team, Thank you for your email. In response to your request, the exact text complained of is identified in Appendix A.

The material is complained of as defamatory under Australian law, and provides a firm formal notice that the material is disputed and has already been reported. The quoted material identifies the specific statements that accuse Legion Killfeed and its owner of hacking, file theft, data theft, malicious code, scam conduct, server sabotage, and related misconduct.

Why the content is complained of as unlawful:

The material is complained of as defamatory because it states damaging factual allegations as facts, not as neutral opinion. The excerpts also include a competitor framing narrative and repeated publication over time. Relevant law: Defamation Act 2005 (NSW), as part of Australia's uniform defamation framework.

Reddit removal procedure:

The supplied Google email already confirms Google asked for confirmation that the Reddit removal procedure had been attempted.

Formal notice:
