I acknowledge your note that Reddit cannot disclose the specific outcome of its investigation. That is not my concern.

My concern is that moderators in r/DayZDiscussions appear to be breaching Reddit's own rules by selectively removing comments from me and from users defending me, while allowing direct competitors to keep publishing and preserving false and damaging allegations about me and my business. That is the conduct I need addressed.

Reddit has been on notice about this for roughly two years. This is not a one-off disagreement between users or a single isolated report. It is a long-running pattern involving competitor-driven false allegations, selective moderation, and the continued publication of seriously harmful claims after repeated notice.

What matters here is not whether Reddit explains its internal decision-making. What matters is whether Reddit stops providing a platform for moderators to enforce rules selectively in a way that protects defamatory competitor material while suppressing responses that challenge it.

I also want it noted that I previously attempted to escalate these concerns through Reddit's legal channels, yet the material remained published. The way these serious defamation and abuse concerns were handled was not acceptable, and the continued availability of the material after repeated reports has only compounded the harm.

The core issue is straightforward: Reddit is continuing to host and publish material posted by direct competitors for the purpose of causing reputational and financial harm to me and my business, while moderators in that subreddit appear to be acting without integrity by removing rebuttals and supportive comments instead of addressing the false allegations themselves.

I am not asking for a procedural explanation. I am asking Reddit to stop hosting this competitor-driven defamatory material and to address the moderation abuse that has helped protect and amplify it.

- ACCC / Scamwatch
- Australian Federal Police
- NSW Fair Trading
- US Federal Trade Commission
- Washington State Attorney General
- Nevada Attorney General
- California Attorney General
- Any other Australian, US, UK, EU/EEA, or other authority with jurisdiction over the handling, surfacing, republication, monetisation, or complaint-handling aspects of this matter

That report to the FBI will be updated to include Reddit's position if Reddit continues to refuse to act.
