Subject: Re: Age requirement notice – unresolved defamation, competitor activity and prior cease and desist

Hi Reddit,

Please note that this is a **lawful request made in good faith** for the removal and preservation of clearly identified defamatory material. Any attempt to ignore it, delay it, or characterise it as duplicative, frivolous, vexatious, or otherwise submitted in bad faith will not absolve Reddit of its legal responsibilities under Australian defamation law (including the Defamation Act 2005 (NSW) and equivalent legislation) or its broader online safety and consumer protection obligations.

I am writing in response to your email about the new Australian minimum age requirement for Reddit accounts.

First, for the avoidance of doubt: **I am 32 years old**. I am not a minor, have not been a minor at any time during the operation of my Reddit accounts, and there is no lawful basis to treat me as under 16 or to interfere with my access on that ground.

Secondly, this age notice does nothing to address the issue you have been on notice about for more than a year: Reddit is still hosting **defamatory content targeting me personally and my Australian business, Legion Killfeed** (software company, see: <https://killfeed.co/>). I issued a formal cease and desist and preservation notice in October 2025 regarding that material, and you have not complied with it. The core thread remains live at:

In that thread and related posts, a small group of users who are not genuine customers but direct or indirect competitors falsely allege that I:

- run “malicious” code
- steal or sell customer files and data
- use FTP or SQL injection to damage servers
- scam people for tokens and money
- wiped someone's Discord server

These are serious, specific allegations of dishonest and even criminal conduct by me and my business. They are false. Under Australian defamation law they are plainly defamatory, and they are causing ongoing serious harm.

Nine days ago, at the same time as a fresh wave of fake Trustpilot reviews was pushed against my business, a new comment was added to that same Reddit thread:

MASSIVE19 • 9d ago

Holy moly guys, I had the worst experience with LegionKillfeed. That soul boy is such a clown. Unwilling to assist with anything. Threats ppl like garbage. You can definitely tell the lawsuits are getting the better of him.

Do yourselves a massive favour and join dayz++ instead. Their services is just 110% better and actually worth your time, money and energy.

There are several important points about this new comment:

1. **There is no evidence this person has ever used my service.** In the last 15 days there have been zero subscription cancellations, and in the last 10 days there have been no new sign ups at all. Whoever “MASSIVE19” is, they are not an identifiable customer and have not interacted with my business through any legitimate channel.
2. **The comment is promotional for a competitor, not a genuine review.** It is framed entirely to deter customers from using Legion Killfeed and push them toward a rival product (“join dayz++ instead”). That is advertising, not consumer feedback. It fits the same pattern as the coordinated Trustpilot spam that began nine days ago, which also attempts to dissuade potential customers while promoting alternatives.
3. **The pattern of competitor involvement is already documented.**

- The original poster is tied to "Kamikaze420" / DayZ Skynet, which is a direct commercial competitor offering a killfeed product that competes with Legion Killfeed.
- That same person has posted in your thread using the account "Brief_Ordinary1438", including comments written in German.
- DayZ++ is operated out of Germany. The fact that the same cluster of accounts alternates between English and German, doubles down on the same false allegations, and now directly advertises DayZ++ strongly suggests coordinated competitor activity rather than independent customer experience.

4. **This sits in complete contrast to verified customer feedback.** On Trustpilot, where identities and payments can actually be verified, Legion Killfeed currently has the highest and most numerous reviews for any killfeed bot in this niche, with an overall score of about 4.8 out of 5 from 53 five star reviews and one four star review. The first page of reviews, consistently describes:

These are real, paying customers describing real interactions, and they say the exact opposite of what your Reddit thread claims. By comparison, common community complaints about DayZ++ focus on slow or absent support, which again highlights that the Reddit narrative is not an honest comparison of services but a targeted smear designed to undermine my business.

- fast, hands on support
- detailed features and reliability
- my direct involvement in solving configuration issues
- long term satisfaction from server owners across multiple countries

In addition to this new "MASSIVE19" promotion for DayZ++, you are already holding extensive evidence of competitor involvement and bad faith, including but not limited to:

- Discord logs showing "I'm_Obviously_Mario" admitting they had been in my community for years before pretending to be a brand new user in order to post on Reddit.
- Screenshots of "Brief_Ordinary1438", "I'm_Obviously_Mario" and others repeating coordinated, fabricated claims about my bot, my servers, my handling of data and my character.
- Screenshots linking the "Brief_Ordinary1438" account and the same circle of people to Mathew Trojanowski / "Kamikaze420" / DayZ Skynet, whose own website and marketing clearly position him as a direct competitor.
- Screenshots of other Reddit users like "MongooseCandid2716" and "Specialist_Arm4258" joining in the same smear campaign while the same moderator account controls the relevant subreddits.
- A Google search for "Legion Killfeed" where this defamatory Reddit thread appears on the first page of results, directly under my official website and other legitimate listings, ensuring maximum harm to my business every time a potential customer researches me.
- Copies of my previous reports to Reddit Admin and the Help Center setting out that this is targeted harassment, impersonation and commercial sabotage rather than legitimate criticism.

All of this has already been set out for you in earlier reports and in my October 2025 cease and desist. You are therefore not a neutral, unaware platform. You are on clear and repeated notice that:

- the allegations in this thread are false;
- the people making them are linked to competing services, not genuine customers; and
- the content is causing ongoing, serious harm to an identifiable Australian business and its owner.

Continuing to host that material, while emailing me about age eligibility for a 16 plus threshold that plainly does not apply to me, does not meet your obligations under Australian defamation law or under the basic expectations for online safety and platform responsibility.

Accordingly, I again require that Reddit:

1. Confirm that your records correctly reflect that I am 32 years old and that the new Australian minimum age law is not a basis to suspend or interfere with my account.
2. Remove or permanently hide the defamatory Reddit content identified in my previous cease and desist, including the r/DayZDiscussions thread above, the new "MASSIVE19" comment and associated cross posts that repeat or amplify the same allegations.
3. Preserve all logs and identifying data relating to the relevant posts, comments, accounts and moderation actions, including but not limited to "Brief_Ordinary1438", "I'm_Obviously_Mario", "MASSIVE19", "MongooseCandid2716", "Specialist_Arm4258" and any linked accounts, as this material is evidence in ongoing and contemplated legal and regulatory proceedings.
4. Provide a substantive written response to my cease and desist explaining what steps Reddit has taken or will take to comply with Australian defamation law and your own stated trust and safety obligations in respect of this matter.

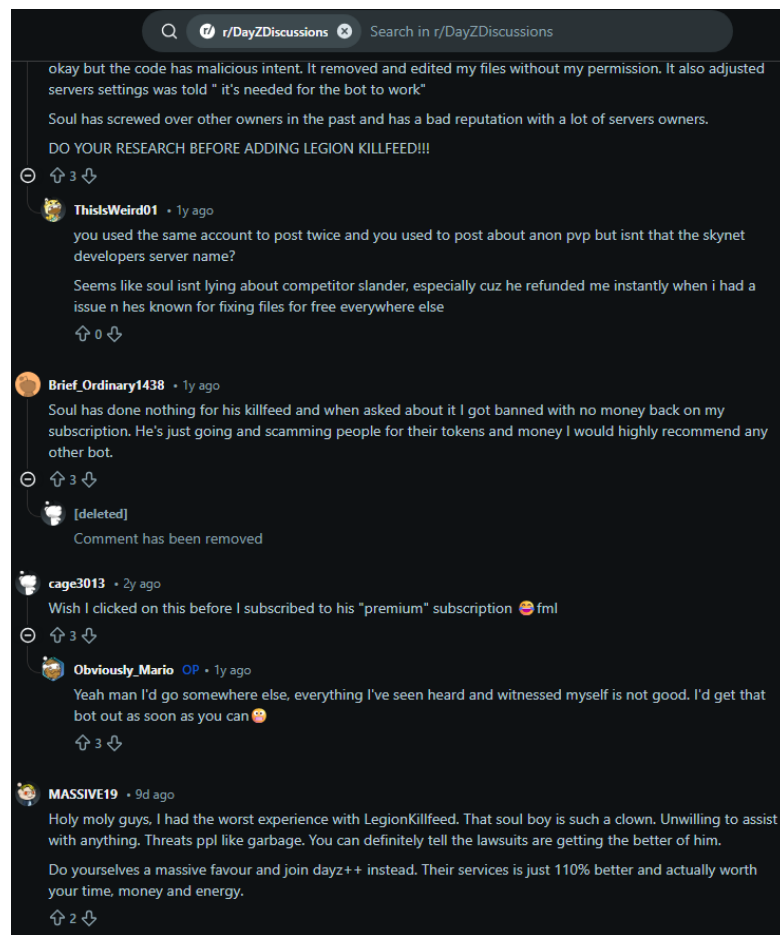

appearance of authority and increases the likelihood that search users accept the allegations as true. Since 2024, I have repeatedly reported the specific post and comment URLs through Reddit's reporting tools and escalations, and I have served formal notices identifying the exact URLs and defamatory excerpts and requesting removal and preservation. Reddit has declined to remove the content, issued template-style responses that do not address the falsifiable claims, and stated it will not preserve or disclose relevant account information without valid legal process. The defamatory material remains accessible and continues to be amplified through Google Search. Additionally, the harm is being amplified by the way Google Search surfaces and prioritises results. Because these URLs rank highly and can be selected or summarised by Google's AI-driven features, defamatory claims are being elevated and repeated over legitimate, verifiable sources such as official business information and genuine review pages. This effectively prioritises unverified allegations as if they were authoritative, increases the likelihood users accept them as true, and directly compounds the reputational and commercial damage. The exploitative nature of this situation is as follows:

- A) The post is reasonably suspected to have been initiated by a direct competitor (or someone acting in concert with a direct competitor) with a commercial motive to damage the business.
- B) There is evidence indicating that the most harmful and repeated false allegations in the thread were posted by sockpuppet accounts linked to that competitor, including activity in a subreddit where the competitor holds moderator privileges, and those accounts are responsible for the core allegations that cause the most damage.
- C) The thread is being actively used as a vehicle to spread demonstrably false claims presented as fact, with the intent and effect of causing business harm, including discouraging subscriptions, provoking cancellations, and driving off-platform harassment.
- D) After being served with a cease-and-desist identifying the defamatory material and requesting removal and preservation, Reddit responded by characterising the notice as "vexatious" and has since refused meaningful engagement, leaving expensive legal process as the only practical avenue for removal or preservation of relevant records. I am requesting removal or delisting from Google Search for the URLs below because continued indexing is amplifying demonstrably false and harmful defamatory allegations about an Australian business and its owner, and those allegations are being used to cause commercial and personal harm. 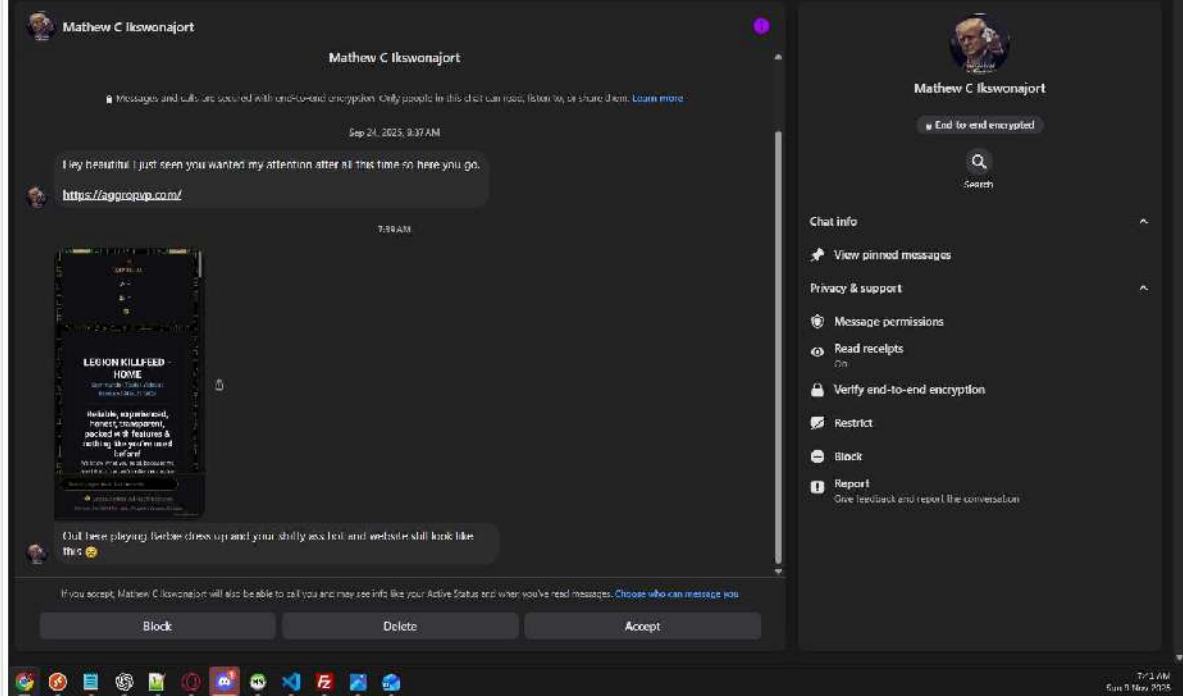

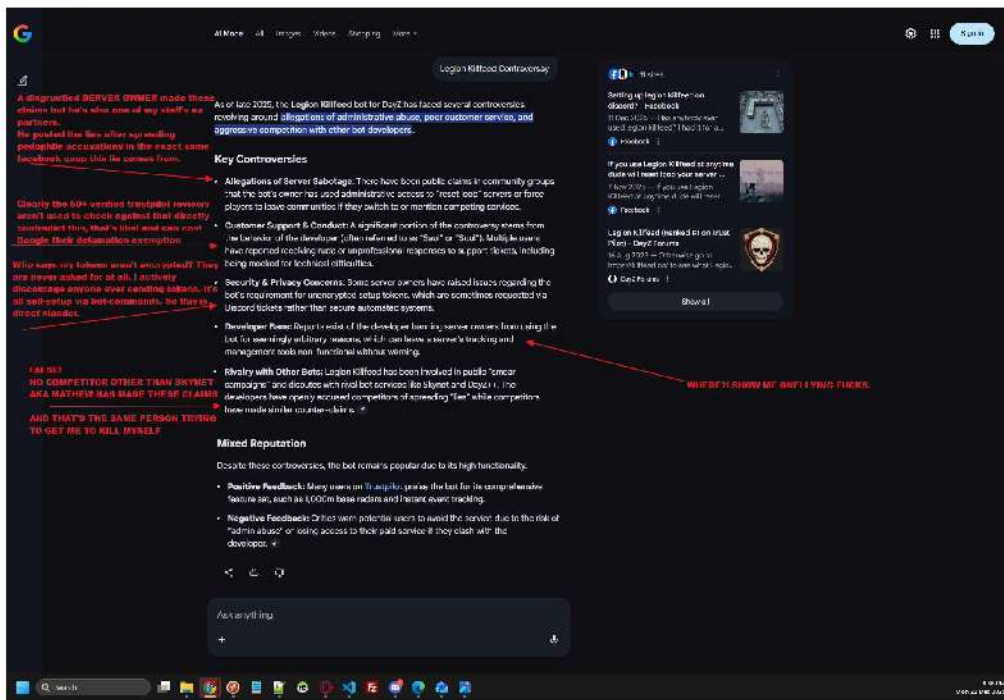

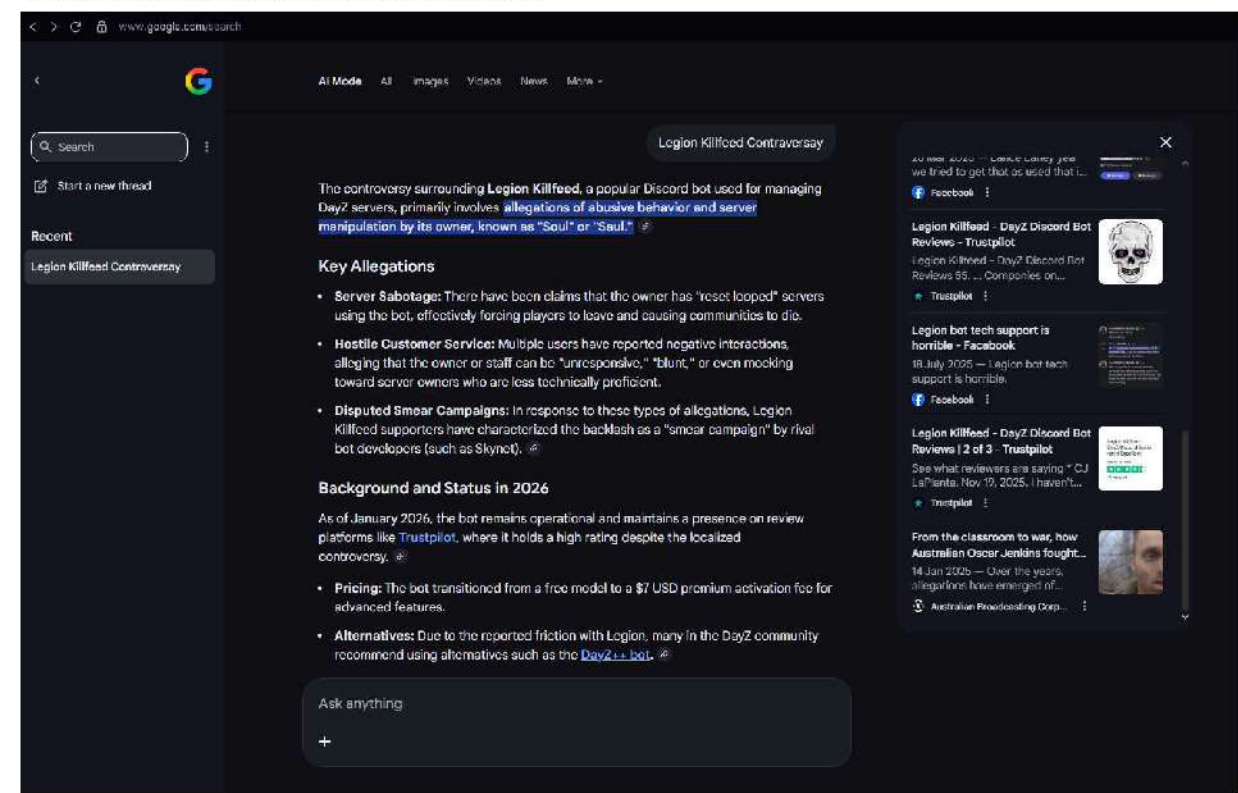

By comparison, common community complaints about DayZ++ focus on slow or absent support, which again highlights that the Reddit narrative is not an honest comparison of services but a targeted smear designed to undermine my business.

In addition to this new "MASSIVE19" promotion for DayZ++, you are already holding extensive evidence of competitor involvement and bad faith, including but not limited to:

- Discord logs showing "I'm_Obviously_Mario" admitting they had been in my community for years before pretending to be a brand new user in order to post on Reddit.
- Screenshots of "Brief_Ordinary1438", "I'm_Obviously_Mario" and others repeating coordinated, fabricated claims about my bot, my servers, my handling of data and my character.
- Screenshots linking the "Brief_Ordinary1438" account and the same circle of people to Mathew Trojanowski / "Kamikaze420" / DayZ Skynet, whose own website and marketing clearly position him as a direct competitor.
- Screenshots of other Reddit users like "MongooseCandid2716" and "Specialist_Arm4258" joining in the same smear campaign while the same moderator account controls the relevant subreddits.
- A Google search for "Legion Killfeed" where this defamatory Reddit thread appears on the first page of results, directly under my official website and other legitimate listings, ensuring maximum harm to my business every time a potential customer researches me.
- Copies of my previous reports to Reddit Admin and the Help Center setting out that this is targeted harassment, impersonation and commercial sabotage rather than legitimate criticism.

All of this has already been set out for you in earlier reports and in my October 2025 cease and desist. You are therefore not a neutral, unaware platform. You are on clear and repeated notice that:

- the allegations in this thread are false;
- the people making them are linked to competing services, not genuine customers; and
- the content is causing ongoing, serious harm to an identifiable Australian business and its owner.

Continuing to host that material, while emailing me about age eligibility for a 16 plus threshold that plainly does not apply to me, does not meet your obligations under Australian defamation law or under the basic expectations for online safety and platform responsibility.

Accordingly, I again require that Reddit:

1. Confirm that your records correctly reflect that I am 32 years old and that the new Australian minimum age law is not a basis to suspend or interfere with my account.
2. Remove or permanently hide the defamatory Reddit content identified in my previous cease and desist, including the r/DayZDiscussions thread above, the new "MASSIVE19" comment and associated cross posts that repeat or amplify the same allegations.
3. Preserve all logs and identifying data relating to the relevant posts, comments, accounts and moderation actions, including but not limited to "Brief_Ordinary1438", "I'm_Obviously_Mario", "MASSIVE19", "MongooseCandid2716", "Specialist_Arm4258" and any linked accounts, as this material is evidence in ongoing and contemplated legal and regulatory proceedings.
4. Provide a substantive written response to my cease and desist explaining what steps Reddit has taken or will take to comply with Australian defamation law and your own stated trust and safety obligations in respect of this matter.

The attached files include screenshots, prior correspondence and review data that collectively demonstrate that these are not honest consumer opinions but a coordinated, competitor driven smear campaign that you have been aware of since at least 2024. Your continued failure to act, despite repeated detailed notice, is causing ongoing and serious harm to me and my business.

Subject: Re: Age requirement notice – unresolved defamation, competitor activity and prior cease and desist

Hi Reddit,

Please note that this is a **lawful request made in good faith** for the removal and preservation of clearly identified defamatory material. Any attempt to ignore it, delay it, or characterise it as duplicative, frivolous, vexatious, or otherwise submitted in bad faith will not absolve Reddit of its legal responsibilities under Australian defamation law (including the Defamation Act 2005 (NSW) and equivalent legislation) or its broader online safety and consumer protection obligations.

I am writing in response to your email about the new Australian minimum age requirement for Reddit accounts.

First, for the avoidance of doubt: **I am 32 years old**. I am not a minor, have not been a minor at any time during the operation of my Reddit accounts, and there is no lawful basis to treat me as under 16 or to interfere with my access on that ground.

Secondly, this age notice does nothing to address the issue you have been on notice about for more than a year: Reddit is still hosting **defamatory content targeting me personally and my Australian business, Legion Killfeed** (software company, see: <https://killfeed.co/>). I issued a formal cease and desist and preservation notice in October 2025 regarding that material, and you have not complied with it. The core thread remains live at:

In that thread and related posts, a small group of users who are not genuine customers but direct or indirect competitors falsely allege that I:

- run "malicious" code
- steal or sell customer files and data
- use FTP or SQL injection to damage servers
- scam people for tokens and money
- wiped someone's Discord server

These are serious, specific allegations of dishonest and even criminal conduct by me and my business. They are false. Under Australian defamation law they are plainly defamatory, and they are causing ongoing serious harm.

Nine days ago, at the same time as a fresh wave of fake Trustpilot reviews was pushed against my business, a new comment was added to that same Reddit thread:

MASSIVE19 • 9d ago

Holy moly guys, I had the worst experience with LegionKillfeed. That soul boy is such a clown. Unwilling to assist with anything. Threats ppl like garbage. You can definitely tell the lawsuits are getting the better of him.

Do yourselves a massive favour and join dayz++ instead. Their services is just 110% better and actually worth your time, money and energy.

There are several important points about this new comment:

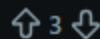
1. **There is no evidence this person has ever used my service.** In the last 15 days there have been zero subscription cancellations, and in the last 10 days there have been no new sign ups at all. Whoever "MASSIVE19" is, they are not an identifiable customer and have not interacted with my business through any legitimate channel.
2. **The comment is promotional for a competitor, not a genuine review.** It is framed entirely to deter customers from using Legion Killfeed and push them toward a rival product ("join dayz++ instead"). That is advertising, not consumer feedback. It fits the same pattern as the coordinated Trustpilot spam that began nine days ago, which also attempts to dissuade potential customers while promoting alternatives.
3. **The pattern of competitor involvement is already documented.**

Those reports flagged targeted harassment, impersonation, and commercial interference. They identified u/Brief_Ordinary1438 as a direct competitor and former staff member engaging in a coordinated smear campaign across Reddit, Discord, and Facebook, and explained that their posts were damaging my business. Admin responses used templates stating "no violation" while leaving the same defamatory content online. My later notices simply repeat the same URLs because Reddit has never dealt with the defamation issue. Re-notifying you while the same material remains live is not bad faith; it is direct evidence that Reddit is continuing publication after notice.

For completeness, I am attaching representative screenshots showing the scope of the defamation, the cross-platform coordination, the competitor involvement, and the real business harm caused:

- Pedophile accusation made in a Discord DayZ community by the same individuals involved in the Reddit thread.
- Facebook posts by the same users coordinating false reports and encouraging others to "get Legion shut down".
- Customer cancellations directly caused by the defamatory rumours.
- Multiple Reddit comments from u/Brief_Ordinary1438 falsely alleging that I hack servers, steal files, inject SQL, sell user data, destroy servers, or run "malicious code".
- Evidence linking "Brief_Ordinary1438" to Mathew Trojanowski, a direct competitor whose own site and posts confirm his involvement in rival services.
- Long-term harassment, threats, impersonation, and cross-platform smear attempts, including suicide-baiting directed at me.
- Additional Discord conversations showing that competitors openly discuss having my business attacked, reported, and shut down.

These records show that:

- the allegations are factual assertions, not opinions
- the statements are false
- the defamatory content is coordinated and commercially motivated
- the harm is real, including financial loss and customer cancellations
- I have reported this repeatedly for over a year
- Reddit has ignored every good-faith attempt to resolve it

The accusations that I hack users, destroy servers, access private files, sell data, or have "malicious code" in my bot are extremely serious. They are fabricated. They meet the serious harm threshold under the Defamation Act 2005 (NSW and harmonised Acts). They target an identifiable Australian business and its owner and have already caused substantial damage.

Labelling my complaint as potentially "frivolous, vexatious or in bad faith" in the face of this documented history will itself be relied on as part of any claim for aggravated damages.

I repeat my key requests:

- Remove the URLs previously notified, including:
https://www.reddit.com/r/DayZDiscussions/comments/19e9029/legion_kill_feed_whats_souls_issue
and the linked comments identified in earlier notices.
- Confirm preservation of all related content, logs and metadata (including account IDs, IP addresses, device identifiers, moderator actions, escalation notes, and prior reports).
- Confirm that this matter has been escalated to the appropriate legal/defamation review team for Australian matters, not dismissed with a generic template.
- Provide a clear written decision on this defamation notice.

Proceedings in Australia are being prepared and will go ahead regardless. If Reddit continues to refuse to process this as a defamation complaint while leaving the material online, I will proceed on the basis that:

- Reddit is a publisher for the purposes of Australian defamation law;
- Reddit has knowingly continued publication after notice; and
- Reddit's dismissals and non-action will be relied upon in support of aggravated damages and costs.
