Legion Kill feed, What's souls issue?

So I am completely confused. I bought a server yesterday morning, changed the loot economy, animal/zombies quantity and spawn points. Got that all set up and noticed a few people join here and there, so I started a discord server last night around midnight and started adding the LegionKillfeed. I got everything set up added my API token which failed a few times till I fixed the permissions. So today I was trying to edit more make a rules list and see what I could do with the kill feed but I deleted a channel so the kill feed left my server and I tried adding it back. Well the API token wasn't working so I tried to get the bots help and accidentally invited to the server instead. I tried the API a few more times and it failed so I was confused I thought all was fixed when soul messaged me asking what's my problem. I responded and said I'm having a problem with setting it up and this is what they replied "Of course you're not, you aren't using a token sending ***** to the bot. You're 100% an alt tryna fuck with my shit. You only had my bot in here get a life". I responded and they stopped texting me. So I joined the kill feeds discord and he had @ me and said what's my problem I said nothing that I just need help, explained and he just kept accusing me of being an alt or something saying because I was the only one in the server I was a fake. I told him I just messed up the channel and he said that my token wasn't a token and that he knows I'm a fake that I have to know who he is because I'm in AGGRO PvP but I've only joined the discord to know the rules other then that I mute all servers unless they specifically @ me. Well he ended up banning me from everything after I asked why he was being so mean and that all I'm trying to do is set up a server for my mom and I. Has this happened to anyone else? Is he always such a douche? He didn't let me prove anything just accused me a bunch and I've never met the dude or had any other interactions yet he was adamant that because I was on aggro I must be some sort of hack or something I'm not sure. I'm just really confused and would like some alternatives to the kill feed I've seen a few but if anyone has any recommendations that are easier for first time users I'd be appreciative.

UPDATE: Soul responded and made a fake account which he accused me of, to comment on this post 2 months later after a few others came forward about his behavior towards them.

UPDATE #2: Soul has made multiple fake accounts now and is still commenting on this post 6 months later!! Don't press on any of the links or anything that he sends I've been informed he's a serious problem in the coding/DayZ community. If you have his bot get it out of your server now! Check any and all commenters post history as most of the accts backing him have just been made!

Your latest response stating that you are "not processing" my report and implying that it may be duplicative, frivolous, vexatious, or submitted in bad faith is noted and rejected.

This notice is made in good faith. I am an Australian business owner dealing with clear, ongoing reputational and financial harm arising from targeted false statements on your platform. I have given you specific URLs, explained the basis in Australian defamation law, and requested removal, preservation, and a clear decision. That is exactly what a good-faith defamation complainant is required to do.

For the avoidance of doubt: this is a defamation complaint, not an Online Safety Act "restricted content" report. You have been on notice about this material since 2024. Every refusal to act after notice is a fresh publication and will be relied on as such.

Your own records show that I have repeatedly used your in-product reporting systems and Help Center in good faith, including but not limited to the reports and admin decisions visible at:

Those reports flagged targeted harassment, impersonation, and commercial interference. They identified u/Brief_Ordinary1438 as a direct competitor and former staff member engaging in a coordinated smear campaign across Reddit, Discord, and Facebook, and explained that their posts were damaging my business. Admin responses used templates stating "no violation" while leaving the same defamatory content online. My later notices simply repeat the same URLs because Reddit has never dealt with the defamation issue. Re-notifying you while the same material remains live is not bad faith; it is direct evidence that Reddit is continuing publication after notice.

For completeness, I am attaching representative screenshots showing the scope of the defamation, the cross-platform coordination, the competitor involvement, and the real business harm caused:

- Pedophile accusation made in a Discord DayZ community by the same individuals involved in the Reddit thread.
- Facebook posts by the same users coordinating false reports and encouraging others to "get Legion shut down".
- Customer cancellations directly caused by the defamatory rumours.
- Multiple Reddit comments from u/Brief_Ordinary1438 falsely alleging that I hack servers, steal files, inject SQL, sell user data, destroy servers, or run "malicious code".
- Evidence linking "Brief_Ordinary1438" to Mathew Trojanowski, a direct competitor whose own site and posts confirm his involvement in rival services.
- Long-term harassment, threats, impersonation, and cross-platform smear attempts, including suicide-baiting directed at me.
- Additional Discord conversations showing that competitors openly discuss having my business attacked, reported, and shut down.

These records show that:

- the allegations are factual assertions, not opinions
- the statements are false
- the defamatory content is coordinated and commercially motivated
- the harm is real, including financial loss and customer cancellations
- I have reported this repeatedly for over a year
- Reddit has ignored every good-faith attempt to resolve it

The accusations that I hack users, destroy servers, access private files, sell data, or have "malicious code" in my bot are extremely serious. They are fabricated. 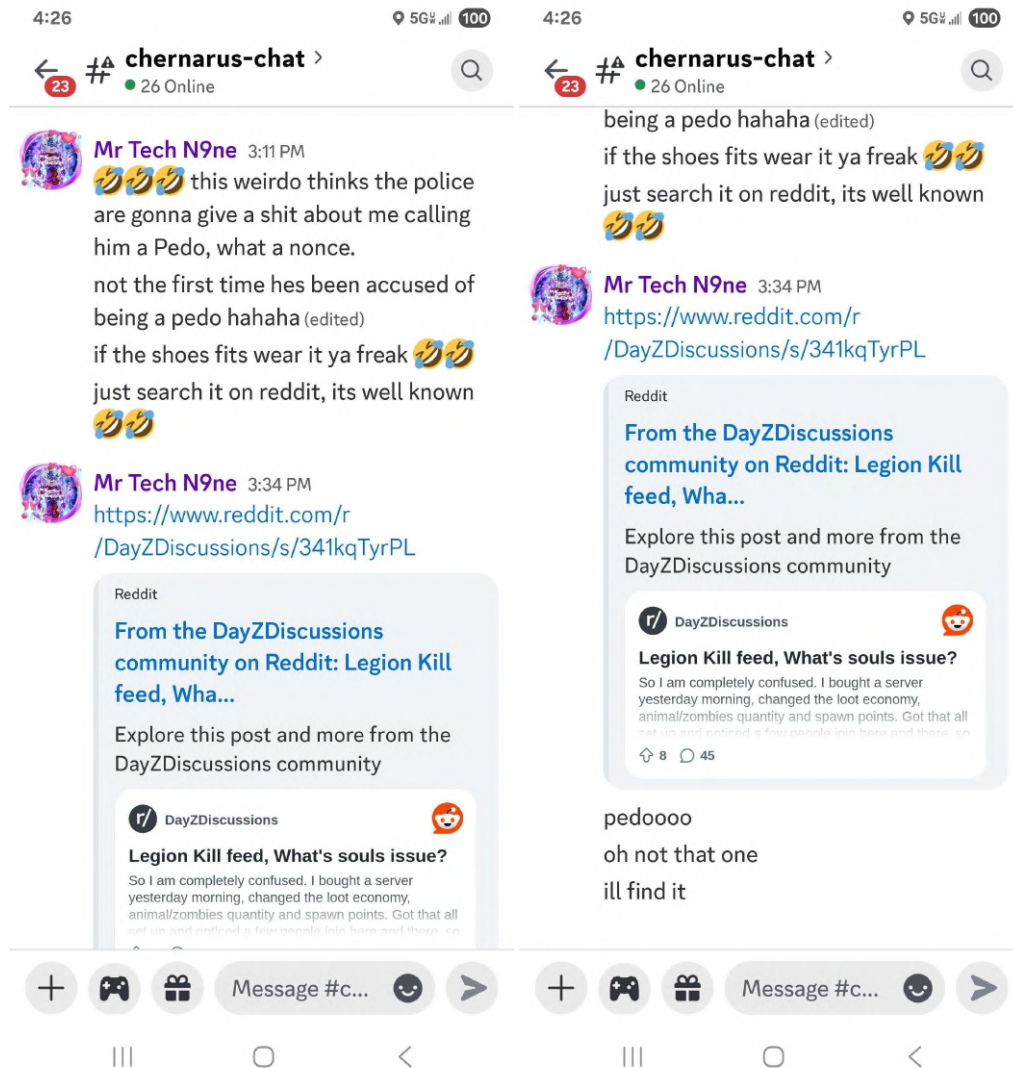

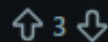

Please note that you have confessed to allowing a competitor to leave a second review after the first one was removed and I absolutely will be making sure that my solicitor is aware of that context.

Quite frankly Rakesh, your excuses for only assessing based on flagging are legally irrelevant.

Regarding Trustpilot's **continued failure to remove – and prevent the republication of – a defamatory review** targeting me and my business on your platform. Despite **multiple takedown requests and substantial documentation** provided to you over the past 18 months, the same false and malicious review has remained accessible or reappeared on Trustpilot. This letter serves as a **final notice** under Australian defamation law and your **final opportunity** to act in good faith **before I initiate formal legal proceedings** in the Supreme Court of New South Wales.

Trustpilot's Failure to Remove Defamatory Content

On numerous occasions, I notified Trustpilot of a blatantly defamatory review about me (Anthony Brodie, owner of *Legion Killfeed*). The content of this review – and others in a targeted "review bombing" – includes **egregious lies and extreme accusations** clearly intended to destroy my reputation. For example, the reviews leveled false allegations that I am a *"scammer" who "takes your money and deletes your server"* and even more despicable smears implying **pedophilia and criminal misconduct**, none of which have any basis in fact. These statements are **unambiguously defamatory**, identifying me and my business by name and imputing the most heinous conduct.

Despite being put on notice repeatedly, Trustpilot failed to remove this harmful content in a timely manner. In fact, your own fraud detection team initially flagged at least one of these reviews (posted under the alias "Z Doneskies") as *"Not based on a genuine experience"* and indicated it *"will be taken offline"* if the reviewer failed to provide proof within 3 days. Another review ("Robert McDonovan") was, according to your correspondence, *filtered* and supposedly *"online for 3 working days only"*. **Yet, in reality these reviews remained visible far longer – and even resurfaced after supposed removal.** One of the defamatory reviews was **inexplicably re-published months after it had been removed/archived**, without any notice to me. I only discovered this republication by chance and was forced to flag the same malign content yet again for removal. This pattern – *remove or mask, then quietly reinstate the defamatory material* – is **unacceptable** and evidences a **bad-faith moderation practice** on Trustpilot's part.

Trustpilot's handling of my complaints has been nothing short of egregious. I have sent **hundreds of notices and follow-ups** (by one count, **382 emails** between July 2024 and September 2025) to ensure Trustpilot was aware of the defamatory content. These efforts included formal "Report Review" submissions through your platform and direct **concerns notices** via email (addressed to your legal and content integrity addresses). Rather than prompt and decisive removal, **Trustpilot ignored or inadequately responded to these notices.** Most disturbingly, **Trustpilot repeatedly reinstated reviews that had been removed after complaints.** This suggests an intentional decision to **re-publish defamatory material after notice**, which can only be viewed as **bad faith (if not retaliatory) conduct** on your part. Each time Trustpilot left the review up or restored it after being alerted, you effectively **republished the defamation** – compounding the damage to me.

It is clear that Trustpilot's internal processes have **utterly failed** in this case. The moderation has been **inconsistent and non-compliant**: on the one hand flagging the review as fake or harmful, but on the other hand **quietly allowing it to remain or return online.** Such **"review tampering"** – removing content under legal pressure only to reinsert it later – has no innocent explanation. It starkly **violates any notion of good faith** in content moderation and disregards the trust users and businesses place in your platform's integrity.

Ongoing Bad-Faith Moderation & Harm Caused

Trustpilot's **systematic refusal to permanently remove the defaming review** and its **active republication** of that content have caused me severe and ongoing harm. Your platform's own records, as well as my detailed evidence log, document the following:

- **Systematic Ignoring of Notices:** Trustpilot received extensive notice of the defamatory content (including the **382 emails** mentioned above), yet largely ignored these or provided only perfunctory responses. This demonstrates a **willful blindness** to known defamation.
- **Deliberate Republishing of Removed Content:** Trustpilot **deliberately reinstated content that had been removed** for defamation, sometimes **immediately after legal complaints.** Such actions appear *intentional* and even **"indicative of retaliatory intent"**, as if to punish or deter me for pursuing the issue. No legitimate content integrity rationale exists for reinstating a review you *know* to be false and injurious.
- **Inconsistent and Contradictory Actions:** Your team has provided **contradictory messages** – for example, acknowledging a review was fake and **"taken offline,"** yet later claiming the matter "closed" while the same review quietly reappeared. This erratic moderation suggests that **Trustpilot's left hand does not know what the right is doing,** or worse, that Trustpilot **chose to prioritize the harasser's content over the victim's rights.** Either scenario reflects *bad faith*.
- **Facilitation of a Harassment Campaign:** By failing to promptly remove the false reviews (and by resurrecting them after removal), Trustpilot became a **central platform amplifying a coordinated harassment campaign** against me. Indeed, these defamatory reviews on Trustpilot have

been used to legitimize and spread the false allegations onto **other platforms** (Facebook, Reddit, Discord, etc.), emboldening a mob of harassers. Trustpilot's inaction thus **facilitated broader abuse** across the internet.

The **reputational and financial harm** resulting from Trustpilot's conduct is substantial. The false allegations (such as vile insinuations of pedophilia, fraud, and other crimes) have gravely damaged my standing in the community and industry. I have been **ostracized and defamed** in the eyes of clients and peers. The harassment stemming from these reviews even impacted my mental well-being and sense of personal safety. From a business perspective, the campaign (sustained in part by Trustpilot's platform) led to a **collapse of nearly half my subscriber base and over 50% contraction in revenue** for *Legion Killfeed*. In real terms, we lost **81 of 170 servers (~47.6%) and 44 of 129 subscribers (34.1%)** from our peak metrics. This dramatic customer exodus and revenue loss directly correlates with the timeline of the defamatory postings and their continued visibility. It is not mere coincidence – **the false reviews urged others to “stay away” and even encouraged fraudulent chargebacks**, which many users apparently heeded, devastating our growth. The **goodwill of my business has been severely eroded** by the stain of these defamations.

Furthermore, Trustpilot's **compliance failures** have aggravated the harm. Under your own Terms and content policies, fake or defamatory reviews should be removed. In this case, you **identified the reviews as likely fake and injurious, yet failed to enforce your policies consistently**. The protracted presence of the defamatory content (in total, the worst review was visible for **weeks across multiple separate periods** despite “removals”) has materially increased the damage. Every additional day of publication post-notice is a new harm – and here we are dealing with content that lingered or returned again and again over many months. This **lack of effective, final removal** and the **republishing after notice** will be viewed by the court as highly aggravating conduct, likely warranting **aggravated damages**.

In summary, Trustpilot's bad-faith moderation has directly caused or exacerbated serious harm to my reputation, business, and well-being. I **have meticulously documented every instance of this harm**, and the record is as unprecedented as it is damning to Trustpilot.

Trustpilot's Liability under Australian Defamation Law

Trustpilot's obligations here are governed by Australian law, as the defamatory publications were **accessible in New South Wales** and caused harm here. I remind you of the **legal framework and your clear liability**:

- **Defamation Elements:** The reviews on Trustpilot **contained false and defamatory imputations** that clearly identify me (by name, business, or context) and were published to third parties. There is no question these elements are met – accusing someone of heinous crimes and dishonesty is defamatory per se. Under Australian common law (and the Defamation Act 2005 (NSW)), Trustpilot by **hosting and actively disseminating** this content to Australian users is considered a **primary publisher** of the defamation. Your role is not a passive one; you *curate and present* user reviews on your site, profiting from their visibility.
- **Publisher Liability After Notice:** Once Trustpilot became aware of the defamatory nature of the content (which indisputably occurred long ago through my complaints), you had a **legal duty to remove it** expeditiously. The **High Court's decision in *Fairfax Media Publications Pty Ltd v Voller* [2021] HCA 27** confirmed that the operator of an online platform is **liable as a publisher from the point they have notice of defamatory material**. Trustpilot was put on notice **repeatedly and emphatically**, yet failed to act or even worse, **acted in a way that maintained the publication**. In line with Voller, Trustpilot became **fully liable for each continued publication and each republication** of the reviews after notice. As your own correspondence aptly noted, *“any response that maintains publication after notice constitutes republication”* of the defamatory material. Trustpilot has engaged in exactly that unlawful republication by leaving the review online and reinstating it after removal. In short, any potential **“platform immunity” evaporated once you were notified** and then chose not to remove the content.
- **No Safe Harbour or Defence Available:** Trustpilot cannot escape liability through any “safe harbour” provisions or defenses under Australian law. The traditional **innocent dissemination defence (Defamation Act 2005 (NSW) s 32)** is **not available** here – it is lost once the publisher has actual knowledge of the defamation and the ability to remove it. You had both knowledge and the technical capacity to delete these reviews, yet you did not do so in a timely or final manner. Likewise, the newly enacted **digital intermediaries defence (s 32A / 31A NSW, post-2021 amendments)**, if it applied to review platforms at all, requires **effective compliance with a notice-takedown procedure**, which Trustpilot manifestly failed to follow. Trustpilot also did not provide a properly functioning complaints system or a timely “reasonable” response as contemplated by law – instead, you ignored notices or inexplicably reinstated content. In sum, **no statutory or common law defence shields Trustpilot** in this scenario. You are **squarely liable as a publisher** of the ongoing defamation.
- **Serious Harm Threshold:** The Defamation Act's **“serious harm” threshold (s 10A)** is clearly satisfied in this matter. I have detailed evidence of serious financial harm (the **loss of clients, subscribers, and revenue** mentioned above) and serious personal harm (extreme humiliation, **distress, and even health impacts** due to the sustained attacks). Under s 10A, a defamatory publication must have caused or be likely to cause serious harm to the plaintiff's reputation. Here, the **harm to my reputation and business has been catastrophic**, far exceeding the minimum threshold. In fact, this case is a textbook example of “serious harm” – the false accusations (e.g. branding me a pedophile or fraud) are so heinous and widely propagated that they inherently and demonstrably caused grave damage.
- **Concerns Notices and Time to Respond:** Australian law (Defamation Act 2005 (NSW), Part 3, as amended) requires that a potential defendant be given a **Concerns Notice** and 28 days to make amends before court proceedings. I have **fully complied with this requirement. All communications to Trustpilot to date – including correspondence on 6 August 2025 and thereafter – have constituted formal concerns notices under the Defamation Act**. You have been given **multiple opportunities and far more than 28 days** to remedy this defamation. For example, a detailed concerns notice was served on **6 August 2025**, outlining the defamatory material and required actions, yet you did not adequately resolve the issue. Even after that notice period elapsed, I refrained from immediate litigation and instead persisted in trying to resolve this matter cooperatively – only to be met with continued non-compliance. **It has now been well over five months since that concerns notice, and the offending review was still being republished as recently as late 2025**, demonstrating a blatant disregard for your legal obligations. In short, the **statutory pre-litigation requirements have been met and exceeded** on my side; Trustpilot has no further grace period to expect.

Given the above, there is **overwhelming evidence of Trustpilot's liability** for defamation under NSW law. You were **expressly aware** of the defamatory content and did not remove it; by contrast, you **republished it after notice**, which will be viewed as an **aggravated instance of defamation**. The courts have little tolerance for publishers who, like Trustpilot here, **knowingly permit defamatory material to remain online**. Notably, in **Barilaro v Google LLC [2022] FCA 650**, Google was ordered to pay **\$715,000 in damages** for failing to remove defamatory YouTube videos after notice. Trustpilot's conduct is equally, if not more, culpable – and you should expect similar if not more severe legal and financial consequences.

Unique Severity and Multi-Platform Dimensions of this Case

I also wish to put Trustpilot on notice that this matter is part of a **broader, uniquely documented defamation and harassment case** that extends beyond just your platform. At least **three other online platforms** (including Reddit, Facebook, and Discord) have been implicated in the **ongoing publication of the same or related defamatory allegations**, often in a **coordinated manner**. The false review on Trustpilot was not an isolated incident; it formed one node in a wider conspiracy to smear my name across the internet. For instance, the **exact same false accusations (pedophilia, fraud, sabotage, etc.) have been propagated on Reddit threads, Facebook posts, and Discord chats**. In some cases, actors on one platform used content from another to lend credibility to their libel (e.g. Trustpilot reviews were linked in Facebook discussions to “prove” the lies, and vice versa).

This cross-platform defamation campaign is **unprecedented in its scope and duration**. To illustrate: the Reddit thread alone attacking me remained live for **706 days** and climbed into Google's top search results. The Trustpilot reviews likewise spanned many months with your platform's complicity. In total, I am dealing with a defamation scenario involving **four major platforms simultaneously (Trustpilot, Reddit, Facebook, Discord)**, plus even **Google's AI summary tool inadvertently amplifying** the false content. The **severity of the allegations** (accusing someone of being a pedophile, among other things) and the **extent of publication** (multiple outlets over a long period) make this case stand out even compared to the most notorious defamation cases in Australia.

By way of comparison, consider that in **Wagner v Harbour Radio [2018] QSC 201**, a case involving a sustained defamatory campaign via radio and related media, the court awarded a total of **\$3.7 million** to the plaintiffs. In **Rolph v Smurthwaite [2023] FCA 1556**, involving false pedophilia accusations on the internet, damages of **\$400,000** were awarded. The defamation against me is no less severe – indeed, calling someone a pedophile is universally recognized as one of the most gravely defamatory imputations. What makes my case even more extraordinary is the **multi-platform, deliberate nature** of the publication. In many respects, this situation is **worse than Wagner**: it involves **more platforms** (multiple websites and social media channels vs. one radio network), a **longer timeframe** (nearly two years of harm), and **more egregious accusations** (pedophilia and criminal fraud vs. the political corruption in Wagner). The **volume and severity of evidence** I have compiled is likely to make this case a landmark precedent once it enters the courts.

Trustpilot's role in this cannot be downplayed. Of all the platforms involved, Trustpilot had perhaps the **clearest notice and simplest path to mitigation** – I flagged the content through your own systems and provided you direct legal notice early on. Trustpilot also had **full ability to instantly remove or at least permanently suppress the defamatory reviews**. Yet, out of the major platforms, **Trustpilot inexplicably stood out by actually republishing content after notice**, something even others did not do. (For example, Reddit at least did not bring a deleted post back online; they refused removal but were consistent in their refusal – whereas Trustpilot removed then reinstated, which is worse.) This will be highlighted as evidence of **bad faith and willful neglect** on Trustpilot's part, contributing to a significant portion of the aggravated damages I will seek. It is telling that even **TikTok**, a platform not even directly targeted in my concerns notices, on its own reviewed and took action to curb the spread of this defamation, **while Trustpilot obstinately refused to do so**. Trustpilot's inaction (and action in restoring the content) effectively gave a green light to the harassers that your site was a safe haven for their smear campaign.

I have been **meticulous in documenting** every facet of this ordeal. My evidence archive contains **1,953 dated entries** (screenshots, emails, logs) that are indexed and cross-referenced to substantiate each allegation I make here. I have preserved proof of what was posted when, how Trustpilot responded (or failed to respond), and the resulting impacts. **Multiple concerns notices have been served not just to Trustpilot but also to the other platforms (Meta/Facebook and Reddit)**, and I have involved regulatory bodies where applicable (such as Australia's eSafety Commissioner and the ACCC for consumer-law aspects). In short, **I am fully prepared for litigation**: a draft Statement of Claim is ready, and the case against Trustpilot (along with others) is comprehensive and well-supported by evidence. Once this moves to court, **Trustpilot's mishandling of this matter will be exposed in open court** in all its detail. The outcome is poised to become a cautionary tale for online platforms, given the extreme facts.

Summary of Damages and Demands

You should be under no illusion about the magnitude of liability and exposure Trustpilot faces in this matter. The damages arising from your platform's publication of the defamatory material (and the subsequent republication and prolonged availability) are extensive. By failing to act in a timely, good-faith manner, Trustpilot has allowed the harm to compound over a lengthy period. I summarize the key categories of harm and damage below, all of which will be claimed in the event of litigation:

- **Reputational Harm:** The false allegations (e.g. branding me a pedophile, scammer, thief of code, drug addict, etc.) have gravely damaged my personal and professional reputation. I am a software developer and service provider; trust and credibility are paramount. These lies on Trustpilot's public forum have led business partners, customers, and community members to **doubt my integrity and even suspect me of heinous crimes**, causing irreparable stigma. My name and my product (*Legion Killfeed*) have been dragged through the mud in search results and public forums. This loss of reputation is incalculable and ongoing – every prospective customer who Googles me or my service finds these defamatory claims, despite their falsity, thus deterring business and destroying goodwill.
- **Business and Economic Loss:** The defamatory review(s) on Trustpilot and their ripple effects have directly caused a significant loss of business. As noted, my subscriber count and active user base plummeted after these allegations circulated. Many existing customers cut ties, and countless potential customers were scared off. I have evidence of specific instances where the Trustpilot reviews were cited by customers as reasons for cancellations or distrust. Additionally, the smear campaign encouraged coordinated **harassment such as**

chargeback fraud (users were urged to file payment disputes en masse), leading to direct financial losses. I have quantified special damages (lost revenue, refunds, time spent on damage control) currently in excess of **AUD \$150,000** on these fronts alone. The business disruption is ongoing, as the false stigma still hampers growth even after the content is (temporarily) removed.

- **Emotional Distress and Personal Suffering:** It is important to note the human toll behind these numbers. Being the target of a malicious defamatory campaign – especially one involving accusations as vile as child predation – has caused me immense stress, humiliation, and anguish. I have endured public hatred and ridicule based on pure fabrications. The situation became so dire that it affected my mental health (including episodes of despair and suicidal ideation, now documented). The **harassment facilitated by your platform** extended to personal attacks on social media and even doxxing of my home address on affiliated hate sites. The Defamation Act's cap on non-economic damages (currently around \$443,000–\$500,000 for non-economic loss) is intended to cover this kind of severe emotional and reputational harm – and I will be seeking damages at the high end of the cap given the **devastating impact on my life**.
- **Aggravated Damages (Bad Faith by Trustpilot):** Trustpilot's conduct throughout this matter has been reprehensible and will warrant aggravated damages. Aggravated (exemplary) damages are awarded when a defendant's actions *in or after* the defamation show egregious wrongdoing or lack of remorse, further hurting the plaintiff. Here, every factor for aggravated damages is present. Trustpilot **knowingly persisted** in the wrongful conduct (repeatedly publishing content you knew was false). You responded to my legitimate complaints with either indifference or contradictory excuses, and took steps (reinstating content) that appear calculated to frustrate my attempts to protect my rights. This **lack of good faith** and the **prolongation of the harm** will significantly increase the damages payable. I note that Trustpilot's **post-notice republication** of the libel, and even **contradicting your own "legal advice"** in correspondence, is nearly unheard-of behavior for a platform – it exemplifies the kind of misconduct aggravated damages were designed to punish. I will absolutely be highlighting this for the court.
- **Non-Compliance and Consumer Law Breaches:** (For completeness, I flag that Trustpilot's failure to remove fake reviews also raises issues under Australian Consumer Law – false or misleading representations by allowing defamatory fake reviews to mislead consumers about my service. While defamation is the primary claim, I reserve the right to pursue ACL claims as well, which can carry penalties.) Additionally, Trustpilot's operations in Australia, post the 2022 defamation law reforms, are subject to certain compliance standards for handling complaints. Your **"automation-first" moderation and failure to provide reasoned decisions** in response to my reports likely breach these standards. These compliance failures reinforce the narrative that Trustpilot cannot be trusted to self-regulate in this matter.

Taking all categories into account, **I estimate the total damages in this matter to be at least in the seven figures**. In fact, my current ****consolidated damages assessment** stands at approximately **AUD \$1,271,820** (and growing). This figure includes general damages (for reputational harm and distress), aggravated damages (for your bad faith conduct), and special damages (for the specific financial losses). To put it plainly: **Trustpilot's liability is already estimated around \$1.3 million** – a number that continues to climb as the harm accrues. This **exceeds a previous settlement offer** I extended to you (which was in the order of \$1.0 million) – an offer you ignored or rejected. That opportunity has now passed, and any resolution will inevitably be more costly given the additional damage since then.

My demands at this stage are straightforward and non-negotiable:

1. **Immediate, Permanent Removal** – Trustpilot must **permanently remove** the defamatory review(s) in question and **ensure they are not republished**. This includes *any* form of the same review (or trivial variations of it) that might exist in your system (e.g. in archives, or if the malicious user attempts to edit and repost it). I expect **written confirmation** that the content has been fully removed and will *not* be allowed to reappear. No more three-day windows, no more temporary "masking" – *permanent deletion* is required.
2. **Preventative Measures** – Trustpilot must implement measures to **prevent republication** of the defamatory allegations. This likely means flagging the relevant user accounts and keywords so that any future attempt to post similar libel is automatically blocked. The fact that your system allowed removed content to resurface indicates a serious flaw that needs addressing. I insist on an **assurance of non-repetition**, given the history here.
3. **Accountability for Bad Actors** – The user accounts involved in this harassment campaign (e.g. the **"Z Doneskies"**, **"Robert McDonovan"**, **"WARZONE"**, **"Karl Messer"** profiles, among others) should be investigated for violating your terms (e.g. leaving only defamatory reviews) and **suspended or banned** from your platform. Allowing known abuse-only accounts to persist is unacceptable.
4. **Confirmation of Compliance in Writing** – I require a written response from Trustpilot outlining exactly what actions have been taken to meet the above demands, and an official position on this matter. Simply removing the review (after all this time) without comment will not suffice; I need clarity that Trustpilot acknowledges the issue and has taken good-faith steps to resolve it and prevent recurrence.
5. **Damages** – Given that this issue has been protracted and the harm done is severe, I am within my rights to seek a **monetary remedy** from Trustpilot for the damage suffered. While my strong preference was to avoid litigation (and I gave you ample chance to resolve this amicably), your inaction has forced my hand. I note that under Australian law, an **"offer to make amends"** (which could include compensation) is a step you could have taken at any point after receiving my concerns notices, but you did not. At this late stage, my expectation is that any voluntary resolution from Trustpilot would include a **substantial damages payment** to compensate for the harm inflicted. If you wish to propose such a resolution, you must do so immediately. Otherwise, this matter will be decided in court, where I will be claiming the full measure of damages (as outlined above, potentially around or above \$1.3M, subject to final calculation).

I have been extraordinarily patient and have given your platform every benefit of the doubt up to now. That patience is exhausted. Your **continued failure to act** in accordance with the law, and the **bad faith pattern of removing and then republishing defamatory content**, leaves me no choice but to proceed to formal legal action. I intend to initiate legal proceedings against Trustpilot and the other platforms involved **without further notice**. Such proceedings will be filed in the **Supreme Court of New South Wales** (Sydney), and I will be seeking all available remedies: **injunctive relief** (to permanently bar further publication of the defamation), **general damages**, **aggravated damages**, and **costs on an indemnity basis**. Given the extensive documentation of your conduct, I am confident in the strength of my case. Once in litigation, I will also pursue through discovery any

internal records at Trustpilot relevant to the moderation (or lack thereof) of these reviews, which likely will further support my claims of knowing negligence or intent.

Be advised that in any court action, **Trustpilot's mishandling of this situation will become part of the public record**. Your emails, actions, and omissions will be scrutinized in open court. The pattern of "masking" reviews after complaints only to **reinstate** them quietly later, the inconsistency between what you told me and what actually happened, the sheer volume of unanswered complaints – all of this will be laid bare. It will be abundantly clear that Trustpilot has engaged in (or allowed) **republication of known defamation**, which is likely to draw not only judicial condemnation but also media and industry attention, potentially damaging Trustpilot's own reputation as a platform. In short, if I am forced to sue, this case will almost certainly become a **high-profile precedent** in Australian defamation law, highlighting Trustpilot's failures.

Take this letter as the final concerned notice and warning. I have been more than reasonable and have complied with all legal prerequisites. The matter now clearly meets the threshold for litigation, and I am prepared to proceed. Remove all of the identified false reviews that still affect my account, like for example, the Havasu review which is the only reference to AI in reviews on my profile and has subsequently caused the false "Artificial Intelligence" tag you display prominently on my profile despite it being "filtered" and most importantly, immediately remove the Consumer/Hooded_Saw lies I have argued with you about for over 60 days, I have included it's last correspondence below. Finally, start discussing settlement offers because there is no way in hell I am simply walking away from the shit your platform has illegally assisted in putting me through. This is **the very last opportunity** for Trustpilot to resolve the issue privately and **to finally demonstrate some good faith** after a long saga of bad-faith moderation. Failing that, we will see you in court.

The abusive way SkyNet Killfeed and Make DayZ Great Again Kill Feed have slandered others

The way SkyNet Killfeed / Sky Net Kill Feed and Make DayZ Great Again Kill Feed have used Reddit, Facebook, Google-indexed posts, AI-generated images, comparison pages, and community groups to smear competitors instead of competing on features, pricing, support, or actual service quality.

This is not normal criticism. This is not “I had a bad experience.” This is repeated character assassination, false criminal allegations, sexual abuse insinuations, scam accusations, and attempts to make those claims surface beside brand searches.

The main targets have included Legion Killfeed and its developer, but the broader issue is the same: DayZ console tooling communities are being poisoned by people using fake accounts, competitor pages, hostile posts, and moderation gaps to damage reputations.

Examples include:

SkyNet-linked Reddit activity repeatedly accusing Legion/Soul of scamming users, stealing files, selling data, using malicious code, FTP abuse, SQL injection, wiping servers, editing server settings without consent, and taking money for subscriptions without providing service.

Make DayZ Great Again / DayZ Console Community posts using hostile Facebook content that calls Legion users “kiddy ticklers,” calls Soul a “pedo,” and pushes sexualised defamatory slurs instead of any verifiable technical criticism.

Facebook posts presenting AI-generated “breaking news” style content as if there was a real DayZ crime operation involving console farms, authorities, underground economies, and gear selling. That kind of content is designed to look like public-interest reporting while pushing panic and suspicion around DayZ server owners and bot services.

Google Search and Google AI results have then picked up pieces of this ecosystem. Brand searches have shown Reddit and Facebook allegations beside Legion’s own site, reviews, Discord, and support pages. That means the harm is not contained inside one group or one post. It is being surfaced to new users at the exact point they are trying to decide whether a service is safe.

One Reddit account, [u/Brief_Ordinary1438](#), has posted multiple different claims across time, including that Legion / u/SoulLags:

- scammed people for tokens and money
- stole or sold files
- used malicious code
- damaged or deleted server files
- abused FTP access
- used SQL injection
- adjusted server settings without permission
- had a bad reputation with server owners

Those are not vague opinions. Those are serious factual allegations. If someone claims a service is stealing data, hacking servers, selling files, or scamming payments, they should be able to prove it with logs, transaction records, Nitrado access records, support tickets, screenshots with context, or a proper technical breakdown.

Instead, the same claims keep appearing in community posts, competitor-adjacent spaces, and search-visible threads.

The Make DayZ Great Again side has also used Facebook group visibility to promote MDZGA while attacking Legion. Screenshots show MDZGA promotion, claims that Legion resets loops or forces players to leave communities, and posts mocking or attacking Legion users. That is not clean competition. That is using a community group as a weapon.

There is also a moderation issue. Some of this material was reported as harassment, impersonation, and targeted abuse, but stayed visible long enough to be indexed, screenshotted, quoted, or reused. When moderation allows obvious competitor-linked abuse to remain public while the accused business has to keep proving the same thing over and over, the platform becomes part of the damage.

The standard should be simple:

- If you have a real complaint, post evidence.
- If you claim a bot stole files, show the access logs.
- If you claim money was taken, show the transaction and support chain.
- If you claim malicious code, show the code.
- If you claim server files were changed, show before/after backups and who had access.
- If you claim criminal behaviour, be prepared to prove it.

What should not be accepted is:

- fake or throwaway accounts making criminal accusations
- competitor groups promoting themselves while attacking rivals
- sexual abuse slurs aimed at developers or users
- AI-generated fake news images framed as “breaking news”
- Google-indexed smear posts being treated like reliable consumer warnings
- moderators ignoring reports because the target is unpopular or commercially inconvenient

DayZ console server owners deserve better than this. People can compare bots, pricing, support, uptime, features, and reliability without inventing criminal allegations or calling people pedophiles.

This thread is not asking anyone to harass, brigade, report-spam, or attack anyone. It is asking people to stop treating smear campaigns as community discussion.

Criticise services fairly. Compare features honestly. Post proof when making serious claims. Stop using DayZ groups and Reddit threads as reputation-damage machines.
