To Google Legal Team,

I refer to matter [1-3859000040385].

You have now been notified repeatedly of the defamatory material targeting me and my business, Legion Killfeed. You have been given the URLs, the exact text, the broader context, the competitor-linked evidence, the search-result URLs, and screenshots showing the material surfacing beside my business name in Google Search. You have also been told that this has caused direct commercial harm and severe personal distress.

I am Anthony Brodie, also known publicly as "Soul" in the DayZ community. I am the owner and operator of Legion Killfeed, which I run as a sole trader. The material complained of identifies both me personally and my business directly. My standing is therefore not in issue.

At this point, failure to delist the complained-of material, or at minimum to suppress Reddit results from appearing for direct brand searches for my business, will be treated by me as a deliberate decision by Google to continue surfacing, ranking, excerpting, redirecting to, and amplifying defamatory material after repeated notice. If Google contends that it can lawfully continue doing so, then say that expressly.

This is not a neutral review thread. It is a competitor-linked smear campaign.

The moderation evidence already supplied shows selective enforcement and materially unequal treatment of comparable content, including my own comment being removed while a rearranged near-identical comment was allowed to remain.

The competitor-linkage evidence already supplied shows that the Reddit account Brief_Ordinary1438 was used to advertise Anon PVP on Reddit, and that Anon PVP was publicly promoted by Mathew Trojanowski on Facebook, tying that Reddit activity to a competing operator.

I also attach screenshots showing that a competitor used Google's own review system to publish damaging material about my business, and that the review was only removed after the fact. That matters because it shows this conduct has persisted even on Google's own services. Google is therefore on full notice that this is an ongoing, competitor-linked pattern, not a historical issue that has ended.

The abuse has run for years across multiple platforms. It has included repeated false allegations that I hack users, steal files, sell customer files or data, use malicious code, destroy servers, abuse FTP or token access, scam customers, and engage in other forms of serious wrongdoing. Google's own April 2026 response also confirms it remains actively reviewing and declining to act on multiple Reddit and related URLs after full notice.

This is causing direct financial harm. The defamatory result has been placed beside my business name in Google Search and has ranked prominently for direct brand queries. I have already provided screenshots showing a real customer-loss pathway: misinformation about my business was repeated by a server staff member after seeing what had been surfaced about me, and only later corrected after I contacted them directly and they apologised for spreading it.

Google is already on notice that any digital intermediary defence under section 31A depends on matters including an accessible complaints mechanism and reasonable access-prevention steps within 7 days of a qualifying written complaint. Section 39A also provides for orders against non-party digital intermediaries in certain circumstances. ([NSW Legislation](#))

The Australian authorities closest on point are not favourable to Google.

In *Duffy v Google*, Google was held liable in South Australia for defamatory search snippets, hyperlinks, and autocomplete after notice, and damages of AUD 100,000 plus interest were awarded. In *Google v Duffy* on appeal, the finding of liability for publication of snippets and hyperlinked articles was upheld. ([CaseNote AU](#))

In *Barilaro v Google LLC* [2022] FCA 650, Google was ordered to pay AUD 715,000. The Federal Court treated Google's ongoing failure to remove the material after notice as conduct that materially aggravated the harm, and the judgment expressly discusses aggravated damages principles, including improper, unjustifiable, or bad-faith conduct after notice. ([ABC News](#))

If Google contends that Deferos allows it to continue surfacing these results, say so expressly. Deferos was a High Court case about search results linking to third-party content where the defamatory matter was not reproduced in the search result itself. That is not the same position as a result format, snippet, text-fragment, or AI/search presentation that reproduces or foregrounds the defamatory sting. ([High Court of Australia](#))

To be clear: I am demanding that Google immediately delist the complained-of defamatory content from Google Search, or at minimum permanently suppress Reddit from appearing in searches for my business name and closely related brand queries if that is Google's preferred technical remedy.

If Google refuses to act, I will escalate this matter to every regulator, authority, and enforcement body with an arguable jurisdictional nexus, including without limitation:

- Office of the Australian Information Commissioner
- eSafety Commissioner
- ACCC / Scamwatch
- Australian Federal Police
- NSW Fair Trading
- US Federal Trade Commission
- Washington State Attorney General
- Nevada Attorney General
- California Attorney General
- Any other Australian, US, UK, EU/EEA, or other authority with jurisdiction over the handling, surfacing, republication, monetisation, or complaint-handling aspects of this matter

A report was filed with the FBI two days ago in relation to similar defamatory material that Meta refused to remove. That report will be updated to include Google's position if Google continues to refuse to act.

Please confirm, by return email:

- whether Google is refusing to delist or suppress the complained-of results;
- whether Google disputes that it is on full notice of the defamatory nature of the material and the competitor-linked context;

- whether Google disputes that its continued indexing, ranking, excerpting, redirecting, and AI/search presentation are aggravating the harm;
- whether Google disputes that this is causing direct financial harm to my business; and
- whether Google will now proceed to remove, delist, or suppress the complained-of results.

If Google's answer is no, then say so plainly.

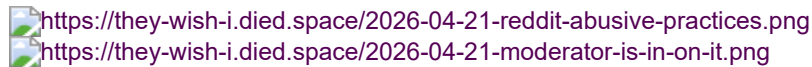

EXACT MATERIAL COMPLAINED OF

The indexed and linked material publishes false statements as statements of fact, including allegations that I and/or Legion Killfeed collect and sell customer files or data, steal files, hack users or servers, destroy or sabotage servers, misuse FTP or token access, use malicious code, scam customers, hijack user files, and alter files or settings without permission.

Examples already identified in prior correspondence include allegations that:

- “Legion Killfeed is just around to collect and sell your files”;
- “Before the killfeed he deleted Greedys server files and also the servers of multiple servers he had FTP access to”;
- “The bot downloads custom files from customers and the owner Soul sells them for profit”;
- “This bot should be watched and avoided ... the code has malicious intent”;
- “Soul is known to use FTP to destroy servers”;
- “If you're looking to get hacked and have your files stolen by Soul ...”.

These are allegations of criminality, dishonesty, unsafe conduct, data misuse, and serious commercial misconduct. They are not harmless insults. They are not neutral summaries. They are not properly verified findings. They are presented as factual accusations and they have caused continuing reputational, commercial and personal harm.

To assist with assessment of this matter, I have a video showing the connections between the Reddit account and a direct competitor, evidence that he is pushing these accusations about me, evidence that he confessed to the very conduct he alleges against me, and evidence that all three of the people actually affected expressly stated it was not me and instead accused him. I expect this matter to now be resolved. This slander is currently being placed beside my business name and is indexing at 2nd result when users search for my business. That is directly causing financial harm. The attached screenshots provide a clear example of that harm in practice, because I have lost customers as a result of these search results being allowed to sit beside my business.

One of the attached screenshot sets relates to a staff member from a server that had been using my service until around 6 months ago. Those screenshots show the misinformation being repeated because of what had been surfaced about my business, and then later show that after I contacted them, they understood the issue and apologised for spreading the misinformation.

LEGAL BASIS

I also rely, separately and without waiving the defamation basis, on the Online Safety Act 2021 (Cth): <https://www.legislation.gov.au/C2021A00076/latest/text> including sections 5 and 7 and Part 7.

This email is not asking Google to remove third-party webpages from the internet. It is asking Google to assess and stop the continued surfacing, ranking, redirecting, snippet generation, and repeated amplification of clearly identified unlawful material after repeated detailed notice.

Please do not treat the different URL forms above as separate issues merely because the same material appears as:

- a direct Reddit thread URL;
- a comment URL;
- a thread/comment path variant;
- a Google redirect URL;
- a Google text-fragment URL;
- a Google share URL; or
- a Google Search results URL showing the same result.

They all concern the same complained-of material and the same continuing harm.

REQUESTED ACTION

I request that Google:

- reassess all URLs listed above together as one consolidated complaint and repeat-surfacing issue;
- delist or otherwise restrict the Reddit result(s) and associated redirect/result formats from Google Search for searches relating to “legion killfeed” and closely related brand queries;
- reassess the related connected URLs listed above that have already been raised in prior Google removals correspondence;
- confirm that my standing as the affected person is no longer in issue;
- confirm that the legal basis above is being considered under the applicable Australian law; and
- confirm receipt of the attached PDFs and screenshots and add them to the assessment record for this matter.

RESERVATION OF RIGHTS

For the avoidance of doubt, nothing in this notice waives any rights I may have in relation to continued publication or republication, including rights relating to preliminary discovery and, where statutory conditions are met, orders against non-party digital intermediaries concerning defamatory digital matter.

Please confirm receipt and proceed with reassessment of all listed URLs on a consolidated basis.
