Explanation of Unlawfulness – Defamation & Cyber Abuse

Jurisdiction: Australia – Defamation Act 2005 (NSW) and Online Safety Act 2021 (Cth)

The content at the listed URLs is unlawful because it constitutes defamation under the uniform defamation laws of Australia and, separately, seriously harmful cyber abuse under the Online Safety Act. The material is not legitimate criticism or opinion; it is a coordinated,

competitor-driven smear campaign that makes provably false factual accusations against an identifiable Australian business and its owner.

1. Publication & Identification

All URLs are publicly accessible. The material expressly identifies the Australian business Legion Killfeed and its owner (known as “Soul”). A reasonable reader would understand the statements to refer to that business and individual.

2. Defamatory Imputations Carried by the Material

The publications convey the following false and damaging imputations of fact:

Criminal / dishonest conduct: The business hacks users, steals files, sells customer files or data, uses malicious code, destroys servers, abuses FTP/token access, and commits fraud.

Scamming: The owner takes money without providing service, refuses refunds, and operates a “scam”.

Technical sabotage: The bot intentionally resets server loops and forces communities to close.

Pedophilia: A Facebook group admin, Joel Walker (also operating MDZGA Killfeed), explicitly labelled the business owner a “pedophile” and “kiddy tickler”. The edit history shows the accusation was added deliberately after a dispute.

Incitement of violence / harassment: Comments in the Facebook thread call for physical harm (“woodchipper”, “knife”, “drag them down a dirt road”) and encourage mass reporting and chargeback fraud.

These imputations are statements of fact, not opinion. They are gravely defamatory – they would lower the reputation of any ordinary person or business in the estimation of right-thinking members of society.

3. Falsity & Malice – Competitor Orchestration

The allegations are false. The business does not hack, steal files, sell customer data, or sabotage servers. The pedophilia accusation is entirely fabricated.

The defamatory content is not organic criticism. It is published by direct competitors:

Joel Walker (aka MDZGA Killfeed) – Admin of the Facebook group “DayZ Console Community” and operator of a competing killfeed service. He edited his post to add the pedophilia accusation and repeatedly “bumps” defamatory posts to manipulate visibility.

Mathew Trojanowski (aka Skynet Killfeed) – Operates competing services (Skynet Killfeed, AggroPVP). Under the alias Brief_Ordinary1438 on Reddit, he posted multiple false technical accusations (file theft, SQL injection, server destruction) while simultaneously promoting his own competing service in other subreddits. His role as a competitor is documented in the evidence (including screenshots of his Reddit advertisements for Anon PVP / Skynet).

The malice and commercial motive are clear: to destroy a rival business and divert customers.

4. Serious Harm (s 10A, Defamation Act 2005 NSW)

The publications have caused serious harm to the business’s reputation and financial position: Direct customer cancellations after seeing the defamatory Reddit thread.

A sharp drop in new sign-ups during and after the Facebook smear campaign.

The defamatory URLs rank prominently in Google Search beside the business name, causing ongoing damage.

Google’s AI Mode now summarises “controversy” about the business and points users to these very Facebook and Reddit allegations, amplifying and legitimising false claims.

This harm is not trivial; it satisfies the serious harm threshold.

5. No Defences Apply

Justification (s 25) – The allegations are false. No evidence supports any of the factual claims.

- Honest opinion (s 29, s 31) – The statements are presented as verifiable facts (“Soul steals files”, “Legion Killfeed resets servers”), not as opinions. They are not based on true or privileged material.
- Qualified privilege / fair report – Not applicable. The publications are not reports of proceedings of public interest; they are malicious attacks by competitors.
- Innocent dissemination (digital intermediary defence) – Not available to the original publishers (Joel Walker, Mathew Trojanowski).

For platforms, any defence under s 31A (Defamation Act 2005 NSW) is lost because they have failed to take reasonable access prevention steps within 7 days of written notice. Google and Reddit have been on notice for over a year and have not removed the material.

6. Specific Provisions of Law Violated

Defamation Act 2005 (NSW) (and equivalent uniform laws):

- s 4 – Definition of defamatory matter: the publications tend to lower the reputation of the plaintiff in the estimation of ordinary reasonable people.
- s 10A – Serious harm threshold is met (see section 4 above).
- s 25 – The defence of justification (truth) cannot succeed because the imputations are false.
- s 29 & 31 – No honest opinion defence because the statements are presented as facts, not opinions based on disclosed true material.
- s 31A – Digital intermediary defence: platforms that fail to act within 7 days of a written complaint lose immunity. Google and Reddit have been notified repeatedly since 2024 and have not removed or de-indexed the URLs.

Online Safety Act 2021 (Cth) – Adult Cyber Abuse Scheme:

- s 20(1) – Material is cyber-abuse if it is intended to cause serious harm and is menacing, harassing, or offensive. The pedophilia accusation and incitement to violence clearly meet this threshold. The eSafety Commissioner has been notified (previous references ACA-2025-0729927, ACA-2024-0528878), but platforms have failed to act.

7 ONLY LEGAL COURSE OF ACTION:

The URLs are not simply “links” to third-party content – Google actively indexes, ranks, excerpts, and in some cases (AI Mode) republishes defamatory snippets. Continued indexing and amplification after repeated notice makes Google a primary publisher liable for defamation under Australian law.

I request that Google:

- De-index all listed URLs from Google Search results.
- Remove all defamatory AI-generated snippets and summaries that appear for search queries involving the business name.
- Confirm in writing that these actions have been taken.

Failure to act within 7 days will be treated as a knowing refusal to comply with Australian law, waiving any safe harbour or intermediary defences, and will be relied upon in court proceedings and regulatory complaints (including the pending FBI report regarding Meta’s similar refusal).

The post remained live and attracted reactions (71 on the first version, 5 on the edited version). The thread contains comments inciting violence, including:

- "all pedos should die"
- "Wood chipper"
- "They should be only killed with knife's to make it painful"
- "drag those fuckers down a dirt road"

The defamatory content is not in the post itself but in the moderator's refusal to remove a comment that recommends a competing service. However, the linked URL is included in your list; the specific defamatory material is the entire thread context where the same group admin (Joel Walker) later used similar tactics. For specificity, the primary defamatory act here is the moderator's complicity in allowing competitor promotion and harassment. Screenshots in the evidence (e.g., 2024-03-22-proof-kami-owns-aggropvp.mp4 and the-harassing-websites.pdf) confirm the site's purpose as part of a competitor smear campaign.

Don't press on any of the links or anything that he sends I've been informed he's a serious problem in the coding/DayZ community. If you have his bot get it out of your server now! Check any and all commenters post history as most of the accts backing him have just been made!"

Defamatory imputation: The post falsely accuses the business owner of being paranoid, abusive, and creating fake accounts, and frames the entire business as a "serious problem".

You're slandering me, accusing me of a crime and saying I abused you it's truly laughable. Someone as you say is so reputable.

Also by the way my post was asking if anyone else has dealt with your douchiness and I quoted you. Anyway I got everything set up without your stupid shit and useless 'help'

Defamatory imputation:

The comment falsely imputes that the business owner (Soul) is insane, seriously paranoid, abusive, a liar, and runs a "poor" business. It asserts that the owner's claims of defamation are false and laughable, that the owner provides "stupid shit and useless help", and that a competitor's product works without problems while Legion Killfeed does not. These are factual assertions of mental instability, abusive conduct, and commercial incompetence, not protected opinion.

Defamatory imputation:

The comment falsely imputes that:

- The business owner is a "clown" (incompetent and ridiculous).
- He is unwilling to provide any assistance to customers.
- He threatens people "like garbage" (abusive and intimidating conduct).
- Lawsuits are "getting the better of him" (implying legal liability, mental deterioration, or impending business collapse).
- A competitor (dayz++) is "110% better" and Legion Killfeed is not worth time, money, or energy.

These are factual assertions of misconduct, incompetence, and commercial worthlessness, presented as objective statements of fact, not as opinion

The content further escalates to hostile, abusive statements and directives encouraging people to remove the

bot, avoid anything associated with me, and treat me as a criminal threat. The obvious and foreseeable effect is serious distress and harm, including reputational destruction, customer cancellations, and further off-platform harassment.

I have reported this material to Reddit previously and Reddit has refused meaningful action, leaving the content live and continuously amplified through Google Search. (This is also consistent with the Online Safety Act complaint framework, which contemplates prior reporting to the service provider in connection with seeking a removal notice.)

In addition, Google's own AI-driven search and ranking systems are actively prioritising this Reddit post, causing it to appear prominently and repeatedly for searches of my business name. This algorithmic amplification spreads provably false allegations as if they were factual, further entrenching reputational harm and exposing Google to potential legal liability for continuing to facilitate the dissemination of defamatory and abusive material after being formally notified.

Given the above, I request that Google delist/remove the Reddit result(s) identified above from Google Search results, including for brand-related searches such as "legion killfeed" and related queries, because continued prominent indexing is materially amplifying cyber-abuse targeted at an Australian adult within the meaning of the Online Safety Act 2021 (Cth).

These posts have caused real-world harm, including customer cancellations, reputational damage, and off-platform harassment. The content remains live and continues to be indexed prominently for brand-related searches, where its high ranking gives it an appearance of authority and increases the likelihood that search users accept the allegations as true. Since 2024, I have repeatedly reported the specific post and comment URLs through Reddit’s reporting tools and escalations, and I have served formal notices identifying the exact URLs and defamatory excerpts and requesting removal and preservation. Reddit has declined to remove the content, issued template-style responses that do not address the falsifiable claims, and stated it will not preserve or disclose relevant account information without valid legal process. The defamatory material remains accessible and continues to be amplified through Google Search. Additionally, the harm is being amplified by the way Google Search surfaces and prioritises results. Because these URLs rank highly and can be selected or summarised by Google’s AI-driven features, defamatory claims are being elevated and repeated over legitimate, verifiable sources such as official business information and genuine review pages. This effectively prioritises unverified allegations as if they were authoritative, increases the likelihood users accept them as true, and directly compounds the reputational and commercial damage. The exploitative nature of this situation is as follows:

- A) The post is reasonably suspected to have been initiated by a direct competitor (or someone acting in concert with a direct competitor) with a commercial motive to damage the business.
- B) There is evidence indicating that the most harmful and repeated false allegations in the thread were posted by sockpuppet accounts linked to that competitor, including activity in a subreddit where the competitor holds moderator privileges, and those accounts are responsible for the core allegations that cause the most damage.
- C) The thread is being actively used as a vehicle to spread demonstrably false claims presented as fact, with the intent and effect of causing business harm, including discouraging subscriptions, provoking cancellations, and driving off-platform harassment.
- D) After being served with a cease-and-desist identifying the defamatory material and requesting removal and preservation, Reddit responded by characterising the notice as “vexatious” and has since refused meaningful engagement, leaving expensive legal process as the only practical avenue for removal or preservation of relevant records. I am requesting removal or delisting from Google Search for the URLs below because continued indexing is amplifying demonstrably false and harmful defamatory allegations about an Australian business and its owner, and those allegations are being used to cause commercial and personal harm.
