FORMAL PRESERVATION DEMAND
NOTICE OF GOOGLE SEARCH, SNIPPET, PREVIEW, AI MODE AND AI OVERVIEW AMPLIFICATION

This is a concerns notice for the purposes of the Defamation Act 2005 (NSW), including sections 12A and 12B.

This notice also operates as a formal preservation demand, repeat legal removal request, and escalation notice concerning Google Search continuing to index, rank, preview, excerpt, cache, summarise, surface, and make searchable defamatory and abusive material beside searches for me, Legion Killfeed, and related commercial search terms.

I am the aggrieved person. I am Anthony “Soul” Brodie, an Australian adult, sole trader, developer, and sole operator of Legion Killfeed. Legion Killfeed is not a detached corporation with separate brand harm. I personally develop it, support it, operate it, and commercially depend on it. False allegations about Legion Killfeed directly identify and harm me personally.

The attached Reddit concerns notice and evidence bundle particularise the underlying defamatory publications. This notice concerns Google’s continued publication, republication, indexing, ranking, previewing, excerpting, snippet generation, AI/Search summarisation, and search-surface amplification of that material after repeated notice.

The material falsely alleges or implies that I and/or Legion Killfeed hack servers, steal customer files, sell customer files, sell customer data, misuse customer data, misuse Nitrado tokens, abuse FTP access, use SQL injection, use malicious code, edit customer files without permission, change server settings improperly, destroy servers, damage Discord servers, scam users for money, scam users for tokens, ban users after taking payment, operate dishonestly, operate unsafely, deliberately sabotage customer communities, reset-loop customer servers, force players away from communities, and are unsafe to trust with Nitrado, Discord, files, tokens, or server access.

Those allegations are false.

This is not fair comment, consumer criticism, or a bad review. A user saying they disliked support, pricing, setup, tone, or the service generally is one thing. Publicly alleging hacking, fraud, theft, data misuse, token abuse, malicious code, SQL injection, server sabotage, and customer-file theft is different.

The matters complained of carry, or are capable of carrying, defamatory imputations including that I am a scammer, that Legion Killfeed is a scam, that I dishonestly take money from users, that I misuse customer access, that I steal or sell customer files, that I sell or misuse customer data, that I hack or sabotage DayZ servers, that I abuse FTP access, that I use SQL injection, that Legion Killfeed contains malicious code, that I edit customer files without permission, that I damage Discord servers or communities, that I am dishonest in the operation of Legion Killfeed, that I am unsafe to trust with server access, and that users should avoid Legion Killfeed because I engage in criminal or near-criminal conduct.

Each imputation is false.

The accusations have not been supported by FTP logs, server logs, Nitrado access records, Discord audit logs, database logs, code samples, exploit details, transaction records, refund records, ticket records, file timestamps, before/after backups, or any other verifiable evidence.
The evidence already provided and preserved shows the opposite. The older FTP/file-loss allegations were not originally made against me. The evidence shows that people involved in that older dispute stated I was not responsible. The evidence also shows that where files were lost, I supplied my own copies back to help people recover what they lost. That conduct is inconsistent with the allegation that I stole, sold, destroyed, or sabotaged files.
The Reddit comments recycle those accusations anyway. Google then gives that material further reach by indexing, ranking, previewing, excerpting, and potentially summarising the accusations in Google Search, Google snippets, Google AI Mode, AI Overviews, panels, generated search outputs, and related search surfaces.
The publications have caused, and continue to cause, serious harm to my reputation, my business, and my personal wellbeing.

This material has been referenced by customers and potential customers. It has been used as supposed proof that the accusations are true. It has been raised in customer conversations, repeated elsewhere, and used to damage trust in Legion Killfeed. The harm is especially serious because Legion Killfeed is a technical service that depends on trust. Users are asked to trust the service with Discord setup, Nitrado integration, file automation, server tools, and support. False allegations that I steal files, scam people, hack servers, sell data, abuse tokens, use SQL injection, or run malicious code strike directly at the core of that trust.
The harm has not stayed on Reddit. The Reddit thread and comments have been indexed, previewed, quoted, screenshotted, linked, repeated, and relied on across search results, AI/search summaries, Facebook/Meta, hostile competitor-linked websites, Lumen notices, and other platform complaints.

Google has already been placed on repeated notice through legal-removal requests, search-removal complaints, Lumen-related notices, attached evidence packages, and search-quality/disavow signals.
The affected site has formally disavowed hostile and abusive domains/URLs through Google’s disavow process. That confirms I am not attempting to benefit from these pages, backlinks, mentions, discussions, snippets, search signals, or hostile references. I have expressly rejected them as abusive, spam-like, competitor-linked, hostile, and harmful.

Those public links are supplementary only. The attached concerns notice and evidence PDFs are the documents served with this notice. Google should assess the material as a connected pattern of defamation, targeted cyber abuse, competitor-linked harassment, commercial sabotage, search manipulation, and search-amplified reputational harm, not as isolated criticism.

GOOGLE SEARCH AND AI AMPLIFICATION

Google is not merely being notified that third-party content exists somewhere online.

Google Search is indexing, ranking, previewing, excerpting, and surfacing the material beside searches for Legion Killfeed, Soul, and related commercial search terms.

Google snippets, cached or derived text, panels, "people also search for" associations, AI Mode, AI Overviews, generated search summaries, or other search features may repeat or legitimise the defamatory allegations.

That causes fresh harm because a user searching for Legion Killfeed can be shown allegations of hacking, fraud, file theft, token abuse, malicious code, SQL injection, and server sabotage in a search context that gives the material reach and apparent relevance.

Google has been told repeatedly that the allegations are false, harmful, unsupported, competitor-linked, and directed at an identifiable Australian adult and sole trader.

AUSTRALIAN LEGAL REFERENCES

Under the Defamation Act 2005 (NSW), this notice provides the location of the matter, the defamatory imputations, the serious harm caused or likely to be caused, and copies or evidence of the matter where practicable.

The serious harm threshold is engaged because the material accuses me and my service of fraud, hacking, theft, data misuse, malicious code, token abuse, SQL injection, server sabotage, and dishonest commercial conduct.

Under the Online Safety Act 2021 (Cth), the material also forms part of targeted adult cyber abuse against an Australian adult. In context, the material is menacing, harassing and offensive, and has been used to drive ostracism, reputational harm, customer fear, and commercial exclusion.

The repeated online publication and amplification of targeted abuse may also be relevant to Criminal Code Act 1995 (Cth), section 474.17, concerning use of a carriage service to menace, harass or cause offence.

Where competitor-linked actors use false claims to divert customers, damage trade, or mislead users about Legion Killfeed's safety, legitimacy, security, or honesty, the conduct may also raise Australian Consumer Law, injurious falsehood, malicious falsehood, and commercial disparagement issues.

INTERNATIONAL LEGAL REFERENCES

United States — defamation, trade libel, unfair competition and false commercial disparagement:

The reported material asserts false facts about theft, hacking, data misuse, malicious code, customer sabotage, server destruction, token abuse, SQL injection, and fraud. If competitor-linked, it may support trade libel, commercial disparagement, unfair competition, or false advertising analysis. Section 230 does not make the original statements true or lawful, does not prevent voluntary removal, and does not answer Google's own search, snippet, AI-summary, notice-handling, and preservation issues.

United States — cyberstalking / harassment context:

Where online services are used as part of a course of conduct intended to harass, intimidate, or cause substantial emotional distress, 18 U.S.C. § 2261A may be relevant. The Reddit thread, Facebook posts, hostile websites, and search amplification should not be assessed as isolated items.

United Kingdom — Defamation Act 2013:

The material raises serious-harm defamation issues if published, accessed, indexed, surfaced, previewed, or relied on in the UK. Allegations of hacking, fraud, data theft, malicious code, SQL injection, server destruction, and dishonest business conduct are grave factual imputations. The material is also relevant to serious financial loss where the affected service depends on customer trust.

United Kingdom — Protection from Harassment Act 1997 and Online Safety Act 2023:

The repeated hostile publication and search amplification may support harassment analysis where it forms part of a course of conduct causing alarm or distress. False or threatening communications may also be relevant where false material is published or amplified with intent to cause harm.

Canada — civil defamation, defamatory libel, criminal harassment and false information context:

The material raises Canadian civil defamation issues because the statements tend to lower my reputation, refer to me and Legion Killfeed, and are published to others. Depending on evidence and intent, Criminal Code provisions concerning defamatory libel, false information conveyed with intent to injure or alarm, criminal harassment, and harassing communications may also be relevant.

European Union / EEA — platform notice and unlawful-content context:

To the extent the material is accessible in the EEA or processed through Google's systems for EEA users, this notice is relevant to platform notice, unlawful-content review, statement-of-reasons records, recommender/search-system records, and online platform risk-management obligations.

REQUIRED ACTION

I require Google to remove or de-index the listed URLs from Google Search.

I require Google to suppress snippets, previews, cached or derived text, highlighted text fragments, panels, generated search outputs, AI Mode results, AI Overviews, and any Google-generated summary that repeats, previews, paraphrases, legitimises, or reinforces the defamatory allegations.

I require Google to stop treating the reported URLs as legitimate authority, reputation, relevance, backlink, discussion, or search-quality signals for Legion Killfeed, my name, or related commercial searches.

I require Google to assess the reported URLs together as a connected pattern of defamation, targeted cyber abuse, competitor-linked harassment, commercial sabotage, and search manipulation.

I require Google to take into account the attached concerns notice, the attached Reddit evidence, the prior Google removal complaints, the Lumen notices, the Google AI/Search complaint evidence, and the fact that the affected site has already disavowed the hostile domains and URLs.

I require Google to preserve records relating to this request and prior related notices, including legal-removal records, search-removal records, internal review notes, escalation notes, decision records, automated review outputs, human-review outputs, search-indexing records, snippet-generation records, AI Mode records, AI Overview records, panel-generation records, cache/derived-text records, disavow-processing records, and records of any decision to continue surfacing the material after notice.

QUESTIONS REQUIRING WRITTEN RESPONSE IF GOOGLE REFUSES REMOVAL

Was this request reviewed by a human?

What jurisdiction or jurisdictions did Google assess?

What legal basis did Google assess?

Why does Google consider the listed material lawful to continue surfacing after repeated notice?

Why does Google consider false allegations of hacking, fraud, file theft, data theft, token abuse, SQL injection, malicious code, and server sabotage to be ordinary criticism?

Why does Google continue surfacing the material when Reddit and Meta reporting pathways have failed?

How did Google account for the affected site already disavowing the hostile domains and URLs?

Will Google suppress snippets, previews, highlighted text fragments, generated search outputs, AI Mode results, AI Overviews, panels, or summaries that repeat or legitimise the allegations?

What records will Google preserve regarding this request and prior related notices?

Whether any Google Search, Google Ads, Google Business, Google indexing, SEO, promotion, or advertising relationship, payment, campaign, or search product activity connected to Joel Lenny Walker, Make DayZ Great Again, mdzga.com, Mathew Trojanowski, DayZ Skynet, killfeed.com, skynetvslegion.com, or related competitor-linked domains was considered or excluded when assessing the visibility of these URLs.

RESERVATION OF RIGHTS

Nothing in this notice should be taken as a waiver of any rights, claims, remedies, or causes of action available to me under Australian law, United States law, United Kingdom law, Canadian law, European Union law, or any other applicable law, including defamation, injurious falsehood, malicious falsehood, misleading or deceptive conduct, trade libel, commercial disparagement, unfair competition, harassment, cyber abuse, platform manipulation, data-protection claims, or any other applicable cause of action.

This is repeat formal notice. Google has been told the specific URLs, the defamatory imputations, the false and abusive nature of the content, the competitor-linked context, the failure of Reddit and Meta reporting pathways, the Google Search and AI amplification harm, the disavow action already taken, and the fact that an Australian adult and sole trader

is personally harmed by this material.

TO BE ABUNDANTLY CLEAR!



Reddit has exercised editorial control while on notice. Reddit then retaliated and banned my account for posting my side of the story. Nothing of mine violated laws (like the post you've been repeatedly put on notice about does). Reddit chose to delete me.



Google's current handling no longer aligns with any claimed neutral search-intermediary position. Google is not merely displaying a passive third-party webpage after notice. It is ranking a hostile forum thread above or beside official sources, allowing the defamatory allegation to remain discoverable by brand-name searches, and using Search/AI features in a way that can summarise, legitimise, or repeat misinformation to users who are deciding whether to trust Legion Killfeed.

This is especially serious because the allegation concerns customer file/data misuse. For a Nitrado-integrated Discord bot, trust in file access and server access is commercially critical. Google's search treatment and AI-assisted search presentation have caused financial harm by exposing prospective customers to false claims that Legion Killfeed collects and sells files, while official Legion Killfeed sources and corrective material are displaced or treated as less authoritative than an anonymous/competitor-linked Reddit forum thread.

After notice, Google cannot reasonably treat this as ordinary indexing. The issue is not only the existence of the Reddit page. The issue is Google's continued search distribution, ranking preference, snippet/preview risk, and AI-assisted amplification of a false factual allegation that Google has now been specifically told is defamatory, harmful, and commercially damaging.

Google was put on formal notice via email yesterday. Why are you committing a crime?
